THIRD AMENDMENT TO NAPA COUNTY AGREEMENT NO. 160092B-22 PROFESSIONAL SERVICES AGREEMENT

THIS THIRD AMENDMENT is made and entered into as of this 1st day of July 2022, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and THE PERMANENTE MEDICAL GROUP, INC., a California corporation, whose business address is 1950 Franklin Street, 20th Floor, Oakland, California, 94612, hereinafter referred to as "CONTRACTOR";

RECITALS

WHEREAS, On May 1, 2016, COUNTY engaged CONTRACTOR in Agreement No. 160092B-16 to obtain specialized services, as authorized by Government Code section 31000; specifically, occupational health and safety medical services including pre-employment physical examinations and annual fitness screenings for County employees when appropriate and needed; and

WHEREAS, On January 8, 2019, COUNTY and CONTRACTOR amended Agreement No. 160092B-16 to 160092B-19 to revise the listing of billable services and update the preemployment physical examinations and annual fitness screenings for County classifications; and

WHEREAS, On July 1, 2020, COUNTY and CONTRACTOR amended Agreement No. 160092B-19 to 160092B-20 to revise the listing of billable services and update the preemployment physical examinations and annual fitness screenings; and

WHEREAS, COUNTY and CONTRACTOR also wish to amend Agreement No. 160092B-16 (as amended, the "Agreement") to extend the term of the Agreement with an auto renewal provision.

WHEREAS, COUNTY AND CONTRACTOR wish to amend the Agreement as follows:

1. Paragraph 1 of the Agreement as of the effective date of the third amendment shall read:

Term of the Agreement. The term of this Agreement shall commence on the date first above written and shall expire on June 30, 2023, unless terminated earlier in accordance with Paragraphs 9 (Termination for Cause), 10 (Other Termination) or 23(a) (Covenant of No Undisclosed Conflict); except that the obligations of the parties under Paragraphs 7 (Insurance) and 8 (Indemnification) shall continue in full force and effect after said expiration date or early termination in relation to acts or omissions occurring prior to such dates during the term of the Agreement, and the obligations of CONTRACTOR to COUNTY shall also continue after said expiration date or early termination in relation to the obligations prescribed by Paragraphs 15 (Confidentiality), 20 (Taxes) and 21 (Access to Records/Retention). The term of this Agreement shall be automatically renewed for an additional year at the end of each fiscal year, under the terms and conditions then in effect, not to exceed two (2) additional years, unless either party gives the other party written notice of intention not to renew no less than thirty (30) days prior to the

expiration of the then current term. For purposes of this Agreement, "fiscal year" shall mean the period commencing on July 1 and ending on June 30.

2. Paragraph 3 of the Agreement, titled Compensation, shall read as of the effective date of the third amendment, as follows:

Compensation.

- (a) <u>Rates.</u> In consideration of CONTRACTOR's fulfillment of the promised work, COUNTY shall pay CONTRACTOR at the rates set forth in Exhibit "B-1", attached hereto and incorporated by reference herein.
- (b) <u>Expenses.</u> No travel or other expenses will be reimbursed by COUNTY.
- (c) <u>Maximum Amount.</u> Notwithstanding subparagraphs (a) and (b), the maximum payments under this Agreement shall be a total of SEVENTY-FIVE THOUSAND DOLLARS (\$75,000) for professional services and ZERO DOLLARS (\$0.00) for expenses per fiscal year; provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered and reimbursable expenses actually incurred. COUNTY shall monitor the total amount of payments owed to CONTRACTOR and shall immediately notify CONTRACTOR when the maximum payment amount permitted under this Agreement is reached. Notwithstanding anything to the contrary in this Agreement, COUNTY shall be liable for and pay CONTRACTOR for any services provided by CONTRACTOR before COUNTY notified CONTRACTOR of the reaching of the maximum payment amount permitted under this Agreement.

3. All references in the Agreement to Exhibit "B-1", as of the effective date of the third amendment shall read Exhibit "B-2."

4. Exhibit B-1 to the Agreement is hereby deleted and a new Exhibit B-2 in the form attached hereto is hereby added to the Agreement.

5. All other terms and conditions of Agreement shall remain in full force and effect.
