RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE TABLE AND INDEX OF CLASSES, EFFECTIVE AUGUST 6, 2022

WHEREAS, Government Code Section 25300 provides that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of county employees and that such action may be taken by ordinance or resolution; and

WHEREAS, Napa County Code Section 2.100.270 provides that the “Table and Index” may be amended from time to time by resolution of the Board of Supervisors; and

WHEREAS, on July 26, 2022, The Board of Supervisors approved salary changes for certain supervisory and management classifications; and

WHEREAS, on July 26, 2022, the Board of Supervisors approved changes to Table and Index of Classes, effective August 6, 2022, but some affected positions were inadvertently not updated;

WHEREAS, the Director of Human Resources recommends that the proposed changes to the Table and Index of Classes, as set forth in Exhibit “A,” be implemented effective August 6, 2022.

NOW, THEREFORE, BE IT RESOLVED, that the Napa County Board of Supervisors hereby approves the changes to the Table and Index of Classes, as set forth in Exhibit “A,” effective August 6, 2022.
