I have completed 6 trials to verdict while working in Napa including several successful prosecutions of child molestation and sexual assault crimes. I obtained a life without the possibility of parole sentence while cochairing a capital murder case, *People v. Sara Krueger and Ryan Warner*, for the 2013 death of a three year old girl by her mother and mother's boyfriend. Other duties include conducting witness and victim interviews, legal research and writing of motions, reviewing search warrants, training police officers, and supervising law clerks.

I worked in various units during my employment including Sex Crimes, Felony Trial Team, misdemeanor trial team, and preliminary hearing deputy. I tried 30 jury trials and 2 court trials to verdict. Other duties I had included working closely with victims of crimes, supervising law clerks and misdemeanor deputies, filing misdemeanor and felony cases, and evaluating and extending offers in order to resolve cases prior to trial.
