EXECUTIVE SUMMARY

Today's action will increase the appropriation for Household Expenses by \$9,800, offset by a donation from the Napa Valley Migrant Farm Worker Housing Committee, also known as the St. Helena Farmworker Committee. Each of the County's owned Farmworker Centers' kitchens would receive equipment to support staff with meal preparation, distribution and storage.

BACKGROUND AND DISCUSSION

The Housing Authority owns three (3) Farmworker Centers located in Calistoga, St. Helena, and Napa. Each center has a commercial kitchen that produces three meals a day, six days a week, and eleven months of the year. At full occupancy (60 lodgers per site), staff serves over 4,000 meals in a month. To help support staff with meal preparation, distribution, and storage, the St. Helena Farmworker Committee has generously volunteered to donate kitchen equipment to each of the three (3) centers.

Today's action will increase the appropriation for Household Expenses by \$9,800, offset by a donation from the Napa Valley Migrant Farm Worker Housing Committee, also known as the St. Helena Farmworker Committee.
