Assessor Parcel Numbers: 024-080-018, 024-080-003, 024-080-022, 024-080-027, and 024-080-021 (SFAP) together with N.C.A.P. No. 024-410-011 (SFAP)

RECORDABLE MEMORANDUM OF AGREEMENT

This Recordable Memorandum of Agreement is made and entered into as of August 19, 2008 by and between the County of Napa, a political subdivision of the State of California (hereafter "County") and Pacific Union College, a California nonprofit religious corporation (hereafter "College").

- 1. County and College entered into a Memorandum of Understanding (hereafter "MOU") on August 19, 2008, for the purpose of working together to complete a Master Plan Feasibility and Alternate Site Selection Study (hereafter "Study") in order to determine the feasibility of the County potentially owning and/or operating the College Airport, located on portions of five separate parcels of real property with the following Napa County Assessor Parcel Numbers: 024-080-018, 024-080-003, 024-080-022, 024-080-027, and 024-080-021 (SFAP) together with N.C.A.P. No. 024-410-011 (SFAP).
- 2. The term of the MOU shall commence the later of the dates when the MOU is signed by both parties or payment is made by the College to County in the sum of \$9,187.50 as set forth in Section 5(a) of the MOU. The MOU shall expire on or before the earlier of: (a) 11:59 p.m. on the last day of the 18th month following the execution of the MOU with the first month for computation purposes being the 1st day of whatever month follows the execution of the MOU; or (b) such time as County determines and notifies College in writing that it is not going to pursue purchasing and/or operating the College Airport.
- 3. During the term of this MOU, and the agreement (if any) for the sale of the College Airport to County, College shall maintain the College Airport as a public use airport and shall not do any of the following: (1) convert the College Airport into non-airport use; or (2) sell, lease, transfer, assign, grant a right of first refusal or option to purchase, or similarly encumber the College Airport. Leasing portions of the airport for use as airport hangars or similar airport related uses or mortgaging the College Airport shall not be deemed a violation of this provision.

- 4. During the term of the MOU, College shall not enter into an agreement for the sale, lease or transfer of any interest in the College Airport if such sale, lease or transfer of interest would result in the conversion of the College Airport to a non-airport use. College covenants that during the term of the MOU (including any extension thereof) it will make known to any person or entity that expresses an interest in acquiring the College Airport and/or the Subject Property, or portions thereof, that the College Airport is currently under study for acquisition by County.
- 5. The College Airport which is the subject of the MOU is described in Exhibit "A" attached hereto.



LEGAL DESCRIPTION PARRETT FIELD – ANGWIN AIRPORT MINIMUM AIRPORT BOUNDARY (MAB)

A portion of Napa County Assessors Parcel Numbers 024-080-027, 024-080-021, 024-080-022, 024-080-003 and 024-080-018, all being the lands of the Pacific Union College Association; more particularly described as follows:

BEGINNING at the intersection of the northerly travelled way of Airport Way and an existing fence, labeled as "P.O.B." on the plat entitled "Plat of Description of the Parrett Field - Angwin Airport Minimum Airport Boundary (MAB) attached hereto and made a part hereof by reference; thence westerly and northerly along said travelled way of Airport Way and College Avenue 1,036 feet more or less; thence westerly 14 feet more or less to a point 265 feet westerly of the centerline of the Parrett Field runway; thence northerly along a line parallel to and 265 feet westerly of said runway centerline 5,899 feet, more or less; thence easterly 530 feet to a point 265 feet easterly of the centerline of the Parrett Field runway; thence southerly along a line parallel to and 265 feet easterly of said runway centerline 5,873 feet, more or less; thence easterly and southerly along a line as shown on the aforementioned Plat of Description 930 feet, more or less to the intersection with the extended line of an existing fence; the westerly along said fence 415 feet more or less to an angle point thereon; thence southerly along said fence 134 feet more or less to the intersection of the extended northerly travelled way of Airport Way; thence westerly along said northerly travelled way 56 feet more or less to the POINT OF BEGINNING.
