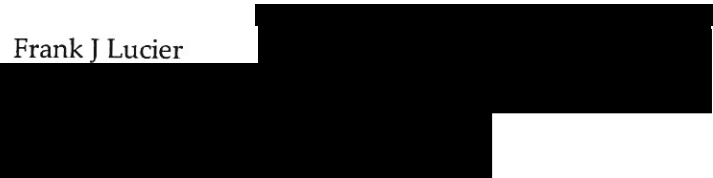



As Executive Director of the Napa County Red Cross we conducted First Aid, CPR and AED training, Disaster Preparedness and Disaster Shelter Operation training, Babysitting and Child Care classes in every community in Napa County. We conducted a summer Swimming and Lifeguard training in St. Helena, a Certified Nurse's Assistant training at the Veterans Home in Yountville, and worked closely with the original Pathway Home training veterans in Shelter Operations so that they could be a trained part of their community when they returned home. My work voluntary work with the Napa County Veterans Advocacy Coalition is driven by the shortfalls in veterans service that I saw when I was with the Red Cross.
