We conducted a summer Swimming and Lifeguard training in St. Helena, a Certified Nurse's Assistant training at the Veterans Home in Yountville, and worked closely with the original Pathway Home training veterans in Shelter Operations so that they could be a trained part of their community when they returned home. My work voluntary work with the Napa County Veterans Advocacy Coalition is driven by the shortfalls in veterans service that I saw when I was with the Red Cross.
