Napa County hereby authorizes and directs Jennifer Palmer, Director of Housing & Homeless Services to execute and deliver all applications and act on Napa County's behalf in all matters pertaining to all such applications.

If an application is approved, the County Executive Officer or designee is authorized to enter into, execute and deliver the grant agreement (*i.e.*, Standard Agreement) and any and all subsequent amendments thereto with the State of California for the purposes of the grant.

If an application is approved, the County Executive Officer or designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
