Please explain your reasons for wishing to serve and, in your opinion, how you feel you could contribute.* As a consumer & a peer advisor of mental health, as well as an employee of Disability Services & Legal Center, where a		
significant number of our consumers have mental health concerns; I am a strong proponent of reducing stigma concerning mental health and increasing the quality and availability of care. I have had the somewhat unique opportunity to see how the mental health care systems work in New York, Florida and California. There is considerable variation on how mental health care is treated in each of these three States. I am well aware of the difficulties faced by people with mental health diagnoses: financially, in getting a desired education or trade, obtaining meaningful work, acquiring affordable housing, building a quality social network with friends and family and securing quality mental health care.		
I have worked to assist others for over four years at Disability Services & Legal Center in Napa. Assisting consumers navigate through the complexities of the Social Security Administration in order to obtain or maintain benefits, because of their mental health and/or physical disabilities. As part of my work at DSLC, I have also assisted consumers with locating and maintaining affordable housing, helped consumers with paperwork for applications for Share the Care of Napa Valley, Season of Sharing and other grants for which consumers may apply for dental care, deposits on housing and moving expenses, home modification, assistive technology, including long term loans of computers so consumers are able to access the internet for information and resources. There are also PG&E's back up battery program for those with medical devises, and government programs such as CalABLE and CalFresh. DSLC also runs an information and referral service so if we aren't able to assist a consumer we refer them to an agency that is able to assist them.		
Over the years, I have gone to Sacramento and Washington D.C. on behalf of agencies and in the company of other consumers to encourage legislators to commit to working on behalf of people with disabilities. I now wish to join the Napa County Board of Mental Health. I hope to be able to serve the Board by listening, learning, and thoughtfully contributing my opinion based on the information I will learn and the information I have learned so far.
