

**RESOLUTION NO. 2022-**

**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE TABLE AND INDEX AND THE DEPARTMENTAL ALLOCATION LIST FOR THE PLANNING, BUILDING AND ENVIRONMENTAL SERVICES DEPARTMENT, EFFECTIVE SEPTEMBER 17, 2022.**

**WHEREAS**, Government Code section 25300 provides that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of county employees and that such action may be taken by ordinance or resolution; and

**WHEREAS**, section 2.100.280 of the Napa County Code provides that the number of positions and classifications in the Departmental Allocation List shall be established from time to time by resolution of the Board of Supervisors; and

**WHEREAS**, section 2.100.270 of the Napa County Code provides that the “Table and Index” may be amended from time to time by resolution of the Board of Supervisors; and

**WHEREAS**, the Director of Human Resources recommends that the proposed changes to the Table and Index of Classes, and Departmental Allocation List for the Planning, Building, and Environmental Services Department, as set forth in Exhibit “A,” be implemented.

**NOW, THEREFORE, BE IT RESOLVED**, that the Napa County Board of Supervisors hereby approves the changes to the Table and Index of Classes and appropriate personnel policies, and Departmental Allocation List for the Planning, Building, and Environmental Services Department, as set forth in Exhibit “A,” effective September 17, 2022.
