

**NAPA COUNTY AGREEMENT NO. 200128B
AMENDMENT NO. 3**

THIS AMENDMENT NO. 3 TO AGREEMENT NO. 200128B is effective as of this _____ day of _____ 2022, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as “COUNTY” and **INNOVATIVE HEALTH SOLUTIONS (formerly Healthy Cooking With Kids, Inc.)**, a California nonprofit corporation, hereinafter referred to as “CONTRACTOR.” COUNTY and CONTRACTOR may be referred to below collectively as “Parties” and individually as “Party.”

RECITALS

WHEREAS, as of October 1, 2019, COUNTY and CONTRACTOR entered into Napa County Agreement No. 200128B (hereinafter referred to as “Agreement”) for CONTRACTOR to provide project coordination and implementation of a California Department of Public Health grant scope of work, convene community partners to develop a Community Nutrition Action Plan, provide nutritional education to low income residents and coordinate a sugar-free beverages campaign; and

WHEREAS, as of October 1, 2019, the Parties amended the Agreement to increase the maximum amount payable for Federal Fiscal Year 2019-2020; modified Section 3--Specific Terms and Conditions 3.1(l) to revise the amount of Federal funding CONTRACTOR receives under this Agreement; and replaced Exhibit B with B-1 (Compensation) to include a revised budget of CONTRACTOR; and

WHEREAS, as of October 1, 2020, the Parties amended the Agreement to increase the maximum amount payable for Federal Fiscal Year 2020-2021; modify Section 3--Specific Terms and Conditions 3.1(l) to revise the amount of Federal funding CONTRACTOR received under this Agreement; and replaced Exhibit B and Exhibit B-1 with Exhibit B-2 (Compensation) to include a revised budget of CONTRACTOR; and

WHEREAS, as of the effective date of this Amendment No. 3, the Parties wish to amend the Agreement to revise Section 3—Specific Terms and Conditions 3.4 to add a provision for automatic renewal for up to one additional federal fiscal year, to increase the maximum amount payable for Federal Fiscal Year 2021-2022 and to add an amount payable for Federal Fiscal Year 2022-2023; modify Section 3—Specific Terms and Conditions 3.1(l) to revise the amount of Federal funding CONTRACTOR will receive under this Agreement; and replace Exhibit A with Exhibit A-1 (Scope of Work) and Exhibit B-2 with Exhibit B-3 (Compensation) to include a revised budget of CONTRACTOR.

TERMS

NOW THEREFORE, for good and valuable consideration, the adequacy and receipt of which are hereby acknowledged, the Parties amend the Agreement as follows:

1. Section 3—Specific Term and Condition 3.4 is revised as follows:

The term of this Agreement shall be automatically renewed for an additional year at the end of each federal fiscal year, for a maximum of one additional federal fiscal year (the final renewal period concludes on September 30, 2023). Under the same terms and conditions, unless terminated earlier in accordance with Paragraphs 2.9 (Termination for Cause, 2.10 (Termination for Convenience) or 2.23 (a) (Covenant of No Undisclosed Conflict). The federal fiscal year commences on October 1st and terminates on September 30th. The obligations of the Parties under Paragraphs 2.7 (Insurance) and 2.8 (Indemnification) shall continue in full force and effect after the expiration date or early termination in relation to acts or omissions occurring prior to such dates during the term of the Agreement, and the obligations of CONTRACTOR to COUNTY shall also continue after the expiration date or early termination in relation to the obligations prescribed by Paragraphs 2.15(Confidentiality), 2.20 (Taxes) and 2.21 (Access to Records/Retention).

2. The maximum amount of payment on Page 1 of the Agreement for Federal Fiscal Year 2021-2022 commencing October 1, 2021 through September 30, 2022, shall be **One Hundred Fifty-Seven Thousand and Two Hundred Thirty-Seven Dollars (\$157,237.00)** of which **Twenty-Three Thousand and Eight Hundred Eighty-Five Dollars (\$23,885.00)** is increased by virtue of this Amendment No. 3, provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered and expenses actually incurred. The maximum amount of payment on Page 1 of the Agreement for Federal Fiscal Year 2022-2023 (October 1, 2022 through September 30, 2023) shall be **One Hundred Forty-Three Thousand and Three Hundred Eighty-Eight Dollars (\$143,388.00)** per fiscal year.

3. Section 3—Specific Term and Condition 3.1(l) is revised as follows:

[X] (1) Services have been determined by the Department Director, or may be determined at a later date, that CONTRACTOR is a subrecipient or pass-through entity and is therefore required to meet all of the requirements found in 2 C.F.R. § 200.331. (General Terms and Conditions 2.40 applies.) COUNTY shall notify CONTRACTOR in accordance with General Terms and Conditions Paragraph 2.13 (Notices), of any change in designation as a subrecipient, and any subsequent increase to the amount of Federal funding CONTRACTOR shall receive under the terms of this Agreement. CONTRACTOR shall be bound thereby upon receipt of notice.

5. Exhibit B-2 shall be replaced with “Exhibit B-3” attached hereto and incorporated by reference herein, and all references in the Agreement to Exhibit B, B-1, and B-2 shall refer to “Exhibit B-3” as of the effective date of this Amendment.
6. Except as provided above, the terms and conditions of the Agreement shall remain in full force and in effect as originally approved and last amended.

SCOPE OF WORK

Innovative Health Solutions

Supplemental Nutrition Assistance Program Education Project

I. Program Description

The overarching goal of the California NEOP SNAP-Ed project is to improve the likelihood that persons from low-income households will make healthy food choices and choose physically active lifestyles, in accordance with current Dietary Guidelines for Americans and Physical Activity Guidelines for Americans.

SNAP-Ed goals will be achieved via partnership between the Local Health Department (LHD), Area Agency on Aging (AAA), and Catholic Charities of California (CCC). Napa County Public Health will accomplish these goals via a subcontract with Innovative Health Solutions (CONTRACTOR) and will concentrate efforts on children and their families through qualified schools, early childhood education facilities, parks, and food assistance sites.

CONTRACTOR will promote nutrition education and physical activity via direct and indirect education activities. In addition, CONTRACTOR will collaborate with and provide technical assistance to various partners around the county to advance the implementation of and support for incorporating health equity initiatives related to food and open space access.
