

**RESOLUTION NO. 2022-\_\_\_**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF NAPA COUNTY, STATE OF CALIFORNIA, INCREASING AND DECREASING RATES FOR THE COLLECTION OF SOLID WASTE, RECYCLABLE MATERIALS, GREEN WASTE AND FOOD WASTE APPLICABLE TO GARBAGE ZONE ONE**

**WHEREAS**, the California Integrated Waste Management Act of 1989 (Public Resources Code sections 40000 et seq.) requires local agencies to make adequate provision for Solid Waste handling within their jurisdictions; and

**WHEREAS**, under the provisions of Chapter 8.48 of the County Code, County has granted to Napa County Recycling & Waste Services, LLC (“NCRWS”) an exclusive franchise for the handling, collection, transportation, recycling and disposal of solid waste in Garbage Zone One of the County, and has set rates associated with the collection and disposal services performed by NCRWS under the franchise; and

**WHEREAS**, in accordance with the provisions of the franchise agreement, NCRWS has applied to the Board for a review and revision of certain rates, and the Board finds there is a need to increase and decrease rates for collection of solid waste, recyclable materials, green waste and food waste; and

**WHEREAS**, Chapter 12.5 of Part 1 of Division 2 of Title 5 of the California Government Code (commencing with Section 54985) and Chapter 8 of Division 1 of Title 7 of the California Government Code (commencing with section 66016) authorize the County to establish fees to recover the cost of providing a service; and

**WHEREAS**, pursuant to Government Code section 66016, at least ten days prior to the date this resolution is to be considered, data was made available to the public indicating the amount of the fee, or estimated fee, required to provide the service for which the fee or service charge is levied and the revenue sources anticipated to provide the service; and

**WHEREAS**, pursuant to Government Code section 66016, at least fourteen days prior to the date this resolution is to be considered, notice was mailed to those persons who had requested same; and

**WHEREAS**, notice of the hearing on the proposed fee was published twice in the manner set forth in section 6062a as required by section 66018, subdivision (a), of the Government Code.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors hereby changes the rates for solid waste, recyclable materials, green waste and food waste as listed in Exhibit “A”, attached hereto and incorporated by reference herein, to commence on October 1, 2022.

**BE IT FURTHER RESOLVED** that the Board finds this resolution is categorically exempt from the California Environmental Quality Act pursuant to Title 14, California Code of Regulations, section 15273(a)(1) and (2).
