

RESOLUTION 25-26-16

RESOLUTION OF THE CALISTOGA JOINT UNIFIED SCHOOL DISTRICT BOARD
OF TRUSTEES SPECIFYING THE CONDUCT OF THE ELECTION FOR
GOVERNING BOARD MEMBERS TO BE HELD ON NOVEMBER 3, 2026

WHEREAS, California Education Code section 5322 requires the Calistoga Joint Unified School District Board of Trustees to adopt a resolution specifying the conduct of the election for governing board members to be held on November 3, 2026, and;

WHEREAS, Education Code 5000 is the authority for conducting such election, and;

WHEREAS, Education Code 5016 requires the Board of Trustees to determine which procedure is to be used for determining the winner in case of a tie vote, and;

WHEREAS, Election Code 13307(e) requires the governing body to specify whether the district or the candidate shall pay for the candidate statement authorized by Election Code 13307(a).

WHEREAS, District boundary lines have changed; the parcels have been reassigned to the St. Helena Unified School District as follows: 021-030-063-000, COOK GLENN E & GAYLE SHURTZ TR, 282 CRYSTAL SPRINGS RD, SAINT HELENA CA 94574-9664, 282 N FORK CRYSTAL SPRINGS RD, ST HELENA CA; 021-030-065-000, COBBLEDICK RANCH LLC, 282 CRYSTAL SPRINGS RD, SAINT HELENA CA 94574, 236 CRYSTAL SPRINGS RD, ST HELENA CA.

NOW, THEREFORE BE IT RESOLVED that the Calistoga Joint Unified School District Board of Education specifies that an election for governing board members will be held on November 3, 2026 and conducted according to the California Elections Code.

BE IT FURTHER RESOLVED that the purpose of the election is to elect two Members of the Board of Trustees of the Calistoga Joint Unified School District.

BE IT FURTHER RESOLVED that pursuant to Education Code section 5016 in the case of a tie vote the winner will be decided by lot election.

BE IT FURTHER RESOLVED that pursuant to Election Code section 13307(e) the cost of candidate statements will be levied against the candidate.
