

**RESOLUTION NO. 2024-**

**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS,  
STATE OF CALIFORNIA, ESTABLISHING INDIGENOUS PEOPLES' DAY AS  
A COUNTY HOLIDAY FOR THE NAPA COUNTY PROBATION  
PROFESSIONALS ASSOCIATION, EFFECTIVE OCTOBER 14, 2024.**

**WHEREAS**, Government Code Section 25300 provides that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of County employees and that such action may be taken by ordinance or resolution; and

**WHEREAS**, the second Monday in October is recognized as an observed holiday for the Deputy Sheriffs' Association, Service Employees International 1021, Napa Association of Public Employees, and unrepresented employees; and

**WHEREAS**, for the reasons stated above, Napa County wishes to add the second Monday in October to the list of observed County Holidays for the Napa County Probation Professionals Association.

**NOW, THEREFORE, BE IT RESOLVED**, that the Napa County Board of Supervisors:

1. Declares Indigenous Peoples' Day as a Napa County observed holiday effective October 14, 2024, and every second Monday in October thereafter; and
2. Directs the Napa County Probation Professionals Association Supervisory and Non-Supervisory Units Memorandum of Understanding with recognized labor representatives be updated to reflect that Indigenous Peoples' Day is a Napa County observed holiday.
