

**NAPA COUNTY AGREEMENT NO. 170879B
AMENDMENT NO. 6**

THIS AGREEMENT is made and entered into as of this 1st day of July, 2024 by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and REDWOOD TOXICOLOGY LABORATORY, INC., a corporation whose mailing address is P.O. Box 5680, Santa Rosa, CA 95402, hereinafter referred to as "CONTRACTOR;"

RECITALS

WHEREAS, COUNTY wishes to obtain specialized services, as authorized by Government Code section 31000, to provide drug screening services for adult and juvenile probationers of COUNTY's Probation Department; and

WHEREAS, on April 1, 2017, COUNTY previously approved Napa County Agreement No. 170879B ("Agreement No. 170879B") with CONTRACTOR to update general terms; and

WHEREAS, on July 1, 2018 and then again on May 1, 2019, COUNTY and CONTRACTOR extended the term of Agreement No. 170879B an additional year; and

WHEREAS, on July 1, 2020, COUNTY and CONTRACTOR revised the Scope of Work and extended the term an additional year; and CONTRACTOR has represented to COUNTY that Mary Tardel, Senior Director, Government Services is authorized individually in the name of and on behalf of CONTRACTOR to enter into such an agreement; and

WHEREAS, on July 1, 2021 and July 1, 2023, COUNTY and CONTRACTOR extended the term an additional year and revised the fee schedule; and

WHEREAS, COUNTY and CONTRACTOR now desire to extend the term an additional year to Agreement No. 170879B; and

WHEREAS, CONTRACTOR is willing to provide such specialized services to COUNTY under the terms and conditions set forth herein; and

TERMS


NOW, THEREFORE, COUNTY and CONTRACTOR hereby amend Napa County Agreement No. 170879B as follows:

C. Transmittal of Samples. COUNTY shall transmit samples to CONTRACTOR by courier, by means of the US Postal Service, or, if six or more samples are being transmitted together, by FedEx. CONTRACTOR shall pay shipping costs for samples transmitted by the US Postal Service or by FedEx.

D. Supplies. CONTRACTOR shall provide COUNTY with the following supplies: testing requisition forms, specimen labels, urine specimen bottles, chain of custody and security seals, and prepaid mailing boxes and FedEx pouches. These supplies shall be promptly replenished as needed. All items shipped, FOB Shipping Point.

E. Expert Witness Fees. CONTRACTOR shall provide COUNTY with court representation/testimony at no cost up to two representations per fiscal year. Additional representation/testimony shall be provided for the additional fee and expense reimbursement set forth in Exhibit "B-6." CONTRACTOR must obtain prior approval from the COUNTY for travel requiring airfare or hotel stays.

F. Maintenance of Licensure/Certifications. During the term of this Agreement, CONTRACTOR shall maintain and keep current the following licenses and certificates, providing COUNTY with written proof of such current licensure and/or certification upon request from COUNTY's Chief Probation Officer or their designee:

- (2) Controlled Substance Registration Certificate issued by the United States Drug Enforcement Administration; and
- (3) Certificate of Proficiency issued by the American Association of Bioanalysts.
