

**NAPA COUNTY AGREEMENT NO. 200401B
AMENDMENT NO. 1**

PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT NO. 1 TO AGREEMENT NO. 200401B is made and entered into as of this ____ day of July, 2022, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and POLLY WEBBER, an individual, whose mailing address is 1207 Cayetano Drive, Napa, CA 94559, hereinafter referred to as "CONTRACTOR";

RECITALS

WHEREAS, COUNTY and CONTRACTOR entered into Napa County Agreement No. 200401B on June 1, 2020 ("Agreement") in order to provide immigration advice to staff attorneys; and

WHEREAS, COUNTY and CONTRACTOR now wish to amend the Agreement to increase the maximum compensation per fiscal year by \$1,640 to a total of \$11,000 per fiscal year, effective for the 2021-2022 fiscal year and onward;

TERMS

NOW, THEREFORE, COUNTY and CONTRACTOR agree to amend the Agreement in accordance with the terms and conditions set forth herein:

1. Paragraph 3 Compensation is amended to read in full as follows:

3. Compensation.

(a) Rates. In consideration of CONTRACTOR's fulfillment of the promised work, COUNTY shall pay CONTRACTOR at the rate set forth in Exhibit "B-1" (Amendment 1), attached hereto and incorporated herein by this reference.

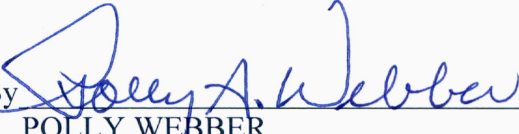
(b) Expenses. No travel or other expenses will be reimbursed by COUNTY.

(c) Maximum Amount. Notwithstanding subparagraphs (a) and (b), the maximum payments under this Agreement shall be a total of ELEVEN THOUSAND DOLLARS (\$11,000.00) for professional services per fiscal year; provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered and reimbursable expenses actually incurred.

2. Exhibit "B" is replaced in its entirety by Exhibit "B-1" (Amendment 1), attached hereto and incorporated by reference herein, and all references to Exhibit "B" shall be construed as referring to Exhibit "B-1" as of July 1, 2021.
3. Except as provided above, the terms and conditions of the Agreement shall remain in full force and effect as originally approved.
