RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE DEPARTMENTAL ALLOCATION LIST FOR THE PUBLIC DEFENDER DEPARTMENT, EFFECTIVE OCTOBER 26, 2024.
