

Please explain your reasons for wishing to serve and, in your opinion, how you feel you could contribute.

Many Veterans are grossly under served as can be attested to by suicide rates and other statistics. We here in Napa County are fortunate to have the resources we do for our local populace. However, there is room for significant improvements in the area of service to Veterans and their families. I am excited to be submitting an online application to serve on the new Napa County Veterans' Commission as serving Veterans is one of my greatest passions! I have been serving Veterans, compassionately, in some capacity for as long as I can remember. I still keep in touch and remain friends with Veterans I met and served during my many years of volunteerism. While in elementary school, I fondly recall having had various war Veteran penpals (though I have no clear recollection of whether it was initiated through school or through some Veteran organization). These are my very first memories on the love of service to Veterans, although at that time I did not think or know of it as "service." After moving to California, I started volunteering in 2001 at the Veterans' Home of California in Yountville through the volunteer department headed by Karen Zanettell. In 2008, I extended my volunteerism to The Pathway Home for PTSD Vets, headed by Fred Gusman. I was interested and uniquely qualified to serve The Pathway Home PTSD Veterans. My Father (deceased and buried in Arlington National Cemetery) was an Army Combat Veteran (Korean and Vietnam wars) that had suffered from PTSD. Because of this, I am intimately aware of the complexities of being in an environment where someone is suffering from PTSD as well as the associated challenges for Families. I have produced and hosted a special series that airs via Biz101U TV through local community stations including Napa, Solano, and Yolo counties. This special series features various Veterans & organizations serving Veterans and provides a forum for each Veteran Guest to tell their story and share advice on how to successfully transition from war

zone to home front. This series was first broadcast in 2016 with the goal of providing a forum and resources for Veterans and Families. Direct Links to resources for Veterans and families was posted to the www.Biz101UTV.com website as part of this endeavor I have brothers, Uncles, Cousins (both female and male), and friends who also served in the military. Some made a successful transition into civilian life and some did not. My contributions to the Commission will include my experience, desire to significantly elevate the quality and accessibility of services for Veterans and their families, organizational skills, relationships, media access and know-how, and compassion for Veterans and their families. I am very actively involved with the local community TV Station productions and can serve as a media conduit for any communications outreach from the Veterans' Commission to the public and Veterans. These are my reasons for wanting to serve and some of the contributions I can provide serving on the new Veterans' Commission!
