**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS,
STATE OF CALIFORNIA, AMENDING Part III: PART 10 OF THE
COUNTY'S POLICY MANUAL TO CONFIRM THE SUNSET
PROVISIONS OF AND QUALIFICATIONS FOR FEE WAIVERS FOR
DISASTER RECOVERY**

WHEREAS, on May 8, 2018, the Board of Supervisors adopted Resolution 2018-52, which amended County Policy Manual Part III: Part 10, to provide needed financial relief to residents who were adversely affected by the 2017 Napa Fire Complex; and

WHEREAS, on August 14, 2018, the Board of Supervisors adopted Resolution 2018-109, which amended County Policy Manual Part III: Part 10 to reduce fees for building permits to replace or repair structures damaged in any declared local emergency; however, one subsection regarding the qualifications for the fee waiver was inadvertently left unchanged, appearing to limit applicability to victims of the 2017 Napa Fire Complex; and

WHEREAS, on May 21, 2019, the Board of Supervisors adopted Resolution 2019-70, which made several general amendments to County Policy Manual Part III, after a fee study to establish updated fees to recover costs for County services. The revisions to Part III: Part 10 were made on a version of the policy that did not include the updated language adopted by the Board with Resolution 2018-109; and

WHEREAS, the Board of Supervisors desires to make substantive and non-substantive corrections to County Policy Manual Part III: Part 10 to effectuate the intent expressed in Resolution 2018-109.

NOW, THEREFORE, BE IT RESOLVED by the Napa County Board of Supervisors as follows:

1. The Board hereby modifies Part III: Part 10 of the County Policy Manual attached hereto and incorporated by reference herein;
2. The Board hereby directs the Clerk of the Napa County Board of Supervisors to integrate the attached changes to Part III: Part 10 of the Board Policy Manual;
3. This resolution shall take effect immediately upon its adoption.
