## **RESOLUTION NO. 2023-**

## RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE TABLE AND INDEX OF CLASSES, EFFECTIVE JULY 1, 2023.

**WHEREAS,** California Constitution Article 11 Section 1(b) provides that the Board of Supervisors shall prescribe the compensation of its members by ordinance; and

**WHEREAS,** on June 15, 2005, the Board of Supervisors approved Ordinance No. 1263, setting the salary of members of the Napa County Board of Supervisors as equal to 47.09% of the salary of the Superior Court Judges; and

**WHEREAS,** on August 10, 2023, the County received notification that the Superior Court Judges received a salary increase of 0.53% effective July 1, 2023; and

**WHEREAS,** pursuant to Ordinance No. 1263, the members of the Napa County Board of Supervisors must also receive a salary increase;

**WHEREAS**, pursuant to Napa County Code Section 2.100.270, the Table reflecting the salary received by the members of the Board of Supervisors must be adjusted accordingly by resolution of the Board of Supervisors; and

**WHEREAS,** the Director of Human Resources recommends that the proposed changes to the Table and Index, as set forth in Exhibit "A," for members of the Board of Supervisors effective July 1, 2023.

**NOW, THEREFORE, BE IT RESOLVED,** that the Napa County Board of Supervisors hereby approves the salary increase for the members of the Board of Supervisors pursuant to Ordnance No. 1362 and hereby approves changes to the Table and Index, reflecting that salary increase as set forth in Exhibit "A," effective July 1, 2023.
