Vice Chair Cooper led the Pledge of Allegiance.

Jose Hernandez, long time Napa County community member and working with LULAC, League of United Latin American Citizens, stated continued concerns and looking for accountability to decades of impacts to the Latino workforce at Upper Valley Disposal Service and Clover Flat Landfill. The landfill closing is bringing some accountability to this matter but still sees the current activities continue to put the community at risk. He would like to see the Company reconcile the decades of impacts to the Latino workforce.

Staff recommends Chair sign Amendment No. 1 to Agreement No. 250242D with Clean Earth Environmental Solutions, Inc., amending the rates of compensation and increasing the per fiscal year maximum amount allowed under the agreement to \$74,000.

BACKGROUND

Upper Valley Waste Management Agency (UVWMA) is currently in year two of a three year agreement with Clean Earth Environmental Solutions, Inc. (Clean Earth) to provide services for mobilization for household hazardous waste events and disposal of collected wastes. The current agreement with Clean Earth allows for rate increases not more frequently than once per calendar year. Clean Earth staff have notified UVWMA of a proposed 5% rate increase. Clean Earth staff stated that the rate increase is to accommodate increases in transportation, disposal and labor. The current per fiscal year maximum amount allowed is \$70,000. The proposed increased to \$74,000 will allow for an overall 5% increase to match with the increased costs with Clean Earth.

A copy of the draft amendment is included as Attachment A - Clean Earth Environmental Solutions - Amendment 1 to Agreement 250242D - DRAFT. The amendment was not yet approved by Clean Earth at the time of agenda publish.

AMENDMENT NO. 1

TO

UPPER VALLEY WASTE MANAGEMENT AGENCY AGREEMENT NO. 250242D PROFESSIONAL SERVICES AGREEMENT

This Amendment No. 1 ("Amendment") is entered into by and between the Upper Valley Waste Management Agency, a joint powers agency created in accordance with the Joint Powers Act (Government Code section 6500 et seq.) ("Agency") and Clean Earth Environmental Solutions, Inc., a Delaware corporation by and through any of its subsidiaries or affiliates located at 933 First Avenue, Suite 200, King of Prussia, PA 19406 ("Contractor").

This Amendment modifies the original Professional Services Agreement between the Agency and Contractor dated June 24, 2024 ("Agreement").

RECITALS

WHEREAS, under the Agreement, Contractor provides the service of conducting temporary Household Hazardous Waste Collection Events for the collection, transportation, and disposal of household hazardous waste generated by the public and Very Small Quantity Generators;

WHEREAS, Agency and Contractor desire to amend the rates of compensation for the abovementioned services; and

WHEREAS, Agency and Contractor desire to extend the Maximum Amount of the Agreement to allow for increased services.

NOW THEREFORE, Agency and Contractor agree to amend the Agreement as follows:

- I. Section 3(a) ("Rates") of the Agreement is amended to read as follows, with deletions denoted by struck through text and additions denoted by underlined text:
 - In consideration of CONTRACTOR's fulfillment of its obligations hereunder and its performance of the Services, AGENCY shall pay CONTRACTOR at the rates set forth in Exhibit "B" "A-1" which is attached hereto and incorporated herein by this reference.
- II. Section 3(b) ("Maximum Amount") of the Agreement is amended to read as follows, with deletions denoted by struck through text and additions denoted by underlined text:
 - Maximum Amount. The maximum payments under this Agreement to CONTRACTOR shall not exceed seventy thousand dollars (\$70,000) seventy four thousand dollars (\$74,000) for professional services (the "Maximum Amount") per fiscal year. CONTRACTOR shall be compensated based upon services actually rendered, and the Maximum Amount shall not be construed as a guaranteed sum. CONTRACTOR agrees to accept such compensation in full satisfaction for services actually rendered.

- III. Integration. This Amendment amends, as set forth herein, the Agreement and except as specifically amended hereby the Agreement shall remain in full force and effect. To the extent there is any conflict between this Amendment and the Agreement, the terms and provisions of this Amendment shall control. This Amendment and the Agreement, including any exhibits attached to the Agreement, integrate all the terms and conditions of the Parties' agreement and supersede all negotiations with respect hereto.
- IV. Severability. If any provision of this Amendment is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions shall nevertheless continue in full force without being impaired or invalidated in anyway.

The Parties hereby enter into this Amendment upon the date of the last signature below.

RECOMMENDATION

CALIFORNIA INTEGRATED WASTE MANAGEMENT ACT DISCUSSION AND POSSIBLE ACTION: Staff to provide an update on the status of activities relevant to the Act.

BACKGROUND

WASTE REDUCTION, RECYCLING, HAZARDOUS WASTE PROGRAMS UPDATE

HAZARDOUS WASTE COLLECTIONS - The fall hazardous waste (HW) collection event is scheduled for Friday October 31, 2025 1:00pm - 4:00pm (business) and Saturday November 1, 2025 8:00am - 1:00pm (residential). The event will be held at the Calistoga Fairgrounds. New this year in addition to HW collection, electronic waste collection and paper shredding, free compost pick up will be available for residents.

Upper Valley Waste Management Agency's (UVWMA) HW collections contractor Clean Earth will mobilize for the temporary event, collect and dispose of HW dropped off by the public. UVWMA pays a flat fee for mobilization dependent upon the number of cars that use the event. Businesses will schedule appointments and pay disposal costs for their materials, residents are not charged a fee and are not required to schedule appointments. UVWMA will pay for HW disposed of by residents.

Electronic waste will be collected by UVDS and document shredding will be provided by a third-party vendor of UVDS during the hazardous waste event. The electronic waste collection and document shredding are one of the three times per year events provided by UVDS at no additional cost per the franchise agreement. The

electronic waste collection and document shredding will be for residents only, not businesses.

The max per drop off for hazardous waste is due to state law, it is 15 gallons or 125 pounds per vehicle for both businesses and residents. The maximum drop off for document shredding will be five banker boxes.

UVWMA will pay for compost distributed to the public, counting towards the annual SB 1383 required organic product procurement target. Compost is only available in bags, one bag holds one cubic foot of compost. There is a max of two bags per resident. It is possible that compost will run out before the close of the event. If that occurs, UVWMA and UVDS will provide a coupon for residents to schedule a time to pick up the compost from the UVDS compost facility.

The entrance and exit for this event have remained the same for many years. However, this year's route will be different. UVWMA staff will work to set up ample signage to direct the public into and through the event. The event entrance will be at the RV park, exit will be next to the Butler Building. There will be four stops at the event in this order - document shredding, e-waste, compost and hazardous waste.

Updated copies of flyers for the event, that include the offer of compost for residents, are included as Attachment A - Calistoga Residential HW 2025 Updated and Attachment B - Calistoga Business HW 2025.

SHARPS AND MEDICATIONS DISPOSAL - SB 212 requires pharmaceutical companies to run statewide stewardship programs that provide safe and convenient disposal options for pharmaceutical and homegenerated sharps waste at no cost to the consumer. Medication collections will be available in receptacles and via pre paid mail back options at no cost to consumers. Sharps will be collected via a secure mail back container at no cost to consumers. Secure sharps mail back containers are to be provided at the point of sale or with five days by stewardship programs and containers can also be requested online. More information on these programs can be found at countyofnapa.org/hazwaste.

In addition to the above mentioned stewardship programs, Clean Earth accepts non-controlled medications and sharps at up-valley hazardous waste collection events. Clover Flat Landfill accepts sharps at no charge during regular business hours. A medication collection bin is located at the St. Helena, Calistoga and Yountville Police Department; non-controlled and controlled medications are accepted.

The fall DEA prescription drug take back day is scheduled for October 25, 2025. UVWMA, Napa County, City of Napa and law enforcement have coordinated for countywide participation and sharps will again be accepted

for drop off along with the medications. The sharps will be collected and disposed of by a medical waste hauler. In previous years costs for sharps collection and disposal were reimbursed by SB 212. UVWMA staff were recently notified that this has changed, costs for sharps collection at temporary events are no longer eligible for reimbursement by the SB 212 program operator. Costs for sharps collection will be shared between UVWMA, Napa County and City of Napa. A copy of a countywide flyer for the event is included as Attachment C -Sharps and Meds Event 2025.

BEVERAGE CONTAINER RECYCLING PROGRAM - UVWMA applies as a regional agency for payments that CalRecycle issues for beverage container recycling programs. Staff use the \$25,000 of funds for beverage container recycling and litter reduction activities. Examples include the purchase of recycling bins for public buildings, community parks, main streets, businesses, schools and public gathering areas, and expenditures related to the installation of water refill stations. UVWMA staff are currently expending the "FY 2023-24" funding cycle, funds for that cycle can be expended through March 1, 2026. UVWMA has received the funds for the "FY 2024-25" funding cycle, funds can be expended between early 2025 (after award) and January 5, 2027. UVWMA staff are preparing an application for the "FY 2025-26" funding cycle, the application is due November 18, 2025. If awarded, funding can be expended between early 2026 (after award) and January 5, 2028.

CALRECYCLE - Each year, CalRecycle Local Assistance and Market Development (LAMD) staff conduct a conference call and site visit with jurisdictions. UVWMA's conference call took place in June and covered annual reporting and compliance with SB 1383. The site visit took place on September 18, 2025. UVWMA staff conducted the following with LAMD staff: visited UVDS compost facility to see winery pomace arriving and beginning the composting process, met with the St Helena Food Pantry to discuss the challenges and successes of food recovery, stopped by Bothe State Park to see the compost collection that has been set up for campers and lastly stopped by a vineyard that received and is using 400 tons of compost that was distributed to go towards SB 1383 procurement targets.

In September, CalRecycle notified Napa County that they have completed the review of Napa County's 2025-2034 capacity planning report, of which UVWMA staff provided capacity information and assisted with completing. All of the information required by the statute has been submitted. A copy of the letter from CalRecycle is included as Attachment D - CalRecycle 2025-2034 Capacity Planning Report Review.

SB 1383 IMPLEMENTATION - UVWMA and UVDS staff continue work together to reach out directly via phone, email and site visit to non-compliant accounts to provide education and assistance with meeting SB 1383 organics recycling requirements.

SB 1383 requires jurisdictions to meet container contamination minimization requirements. One way to meet

these requirements is by conducting route reviews of all hauler routes for prohibited container contaminants once per year. Within routes, containers may be randomly selected along the route for further inspection and enough containers must be inspected in to order to adequately determine overall compliance. This further inspection is typically called "lid flips".

Residential lid flips were completed in July and information on the inspections was provided at the August meeting.

Commercial lid flips took place in September and October. Trash, recycling and compost bins and carts were inspected at 30 businesses in the categories of grocery store, lodging, multi family dwelling, restaurant, school and winery. UVDS staff will provide a verbal report of the findings of the inspections.

UVWMA plans to procure organic products (compost) on behalf of member jurisdictions to meet 2025 targets. SB 1383 local assistance grant funding will be used to pay for compost purchases. The targets for 2025 are 4,343 cubic yards or 1,737 tons of finished compost. Approximately 170 tons of compost remains to be distributed.

In summer 2024, UVWMA partnered with the City of Napa and Napa County to release funding to expand the countywide capacity for edible food recovery. Two projects were awarded, \$50,000 to Feeding it Forward (FIF) to retrofit an electric van with refrigeration and \$40,000 to Community Action of Napa Valley (CANV) to purchase a vehicle to pick up smaller loads of excess edible food. In September, both FIF and CANV requested and received approval to adjust their project scopes and extend their agreements through the end of FY 25/26 to allow time to complete their projects.

SB 1383 requires jurisdictions to provide a way for the public to make a complaint about an alleged violation to SB 1383. UVWMA staff have received a complaint regarding a lack of trash bins for customers at an eating establishment where customers bus their own tables. UVWMA staff are investigating the complaint with the assistance of St Helena Code Enforcement staff and input from CalRecycle.

OUTREACH - UVWMA's multi family dwelling outreach consultant, Soluna Outreach Solutions, has begun contacting multi family dwelling managers and owners. Onsite resident training and drop off of resources like brochures and compost pails as begun. UVWMA is in the process of ordering custom recycling bags, to provide to multi family dwelling residents with limited space, to collect their recyclables and take them out to enclosures.

BUSINESS ASSISTANCE PROGRAM - UVWMA and UVDS offer free assistance to any business requesting help in improving waste diversion, it is also available to any business working to become complaint with SB 1383 and is often offered in the initial direct outreach to businesses who are notified they are not compliant with SB 1383. Assistance includes: a walk through to assess needs, UVDS suggested service changes to allow for compliance with SB 1383, recycling and composting interior bins, staff trainings, interior and exterior signs, interior bins stickers and on going support. Businesses may request assistance by calling UVDS at 707-963-7988 or emailing UVWMA at upvalleyrecycles@countyofnapa.org.

ZERO WASTE EVENT SUPPORT - UVWMA staff have created and made available a Request for Zero Waste Event Support application. The purpose of the form is to request from UVWMA a one-time reimbursement of up to \$250 for efforts relating to making events that are free and open to the public zero or low waste. Reimbursements for the following items will be considered: temporary recycling and/or compost service, temporary bins for waste sorting stations, clear bags for recycling or compostable bags for compost, compostable service ware and signs for bins. The application was included in the October 2022 agenda packet, requests can be made via email to upvalleyrecycles@countyofnapa.org.

HOME COMPOSTING WORKSHOPS - Workshop co-sponsors, UVWMA, Napa County, City of Napa, and Napa County Master Gardeners are working to schedule countywide 2026 workshop dates. The up valley workshop for 2026 has been scheduled for May 16, 2026 at the up valley campus. This early scheduling will allow for extra promotion of the event in the Up Valley College spring schedule. The up valley compost workshop will be a dual workshop again, where attendees choose to either learn about backyard composting or worm composting.

Subject: Review Complete for Napa County's 2025–2034 Capacity Planning Report

David Briggs:

The Department of Resources Recycling and Recovery (CalRecycle) staff has reviewed Napa County's (County) Capacity Planning Report that was due on August 1, 2024, and covers January 1, 2025, through December 31, 2034. CalRecycle determined that the County has submitted the required capacity planning reporting information as specified in Title 14 of the California Code of Regulations Section 18994.2(i).

CalRecycle estimates that California needs approximately 50–100 new or expanded organic waste recycling facilities to achieve the goals set forth in SB 1383 (Lara, Chapter 395, Statutes of 2016). Edible food recovery infrastructure is also necessary to allow commercial edible food generators to meet their regulatory requirement to recover all edible food that would otherwise be disposed. Capacity planning is vital to help the state meet these goals.

MOU EXTENDING THE \$300,000 COMMITMENT TOWARDS A FUTURE PUBLIC BENEFIT PROJECT DISCUSSION AND REQUESTED ACTION: Authorize the Agency Manager to sign the attached memorandum of understanding, extending the time frame to implement a public benefit project using the \$300,000 designated in Section 4.1 of the Franchise Agreement.

BACKGROUND

Section 4.1 of the Amended and Restated Franchise Agreement between the Agency and the Contractor dated October 19, 2020 ("Franchise Agreement") states in relevant part:

[I]f the terms and obligations contained in the Fourth Amendment to Agency Agreement #95-06 regarding 'Phase Two' of a Construction and Demolition Debris Program (CDP), or of another similar program that is reasonably satisfactory to the Agency, are not satisfied by June 30, 2025, Contractor shall repay to the Agency its payment for costs associated therewith in the amount of three hundred thousand dollars (\$300,000) no later than thirty (30) days after receiving notice from the Agency.

Back in 2020 when the Franchise Agreement was last updated, the agreement included a provision for the Landfill to make \$300,000 worth of improvements at their main gate that would benefit service to the public. Since that agreement was signed, the Company has made the decision to close the Landfill, rendering these potential improvements moot.

The purpose of this agenda item is to authorize the Agency Manager to sign a memorandum of understanding that requires the company to continue to hold the \$300,000 (with interest), and to propose, for the Board's approval, a future project that will benefit the public using these funds.

MEMORANDUM OF UNDERSTANDING

Between

Upper Valley Waste Management Agency and Clover Flat Land Fill, Inc.

Re: Use of \$300,000 Public Benefit Funds under Section 4.1 of the Franchise Agreement

This Memorandum of Understanding (MOU) is entered into as of October 20th 2025 (the "Effective Date"), by and between the Upper Valley Waste Management Agency, a joint exercise of powers authority organized and operating under California Government Code section 6500 et seq. ("Agency") and Clover Flat Land Fill, Inc., a California corporation ("Contractor"), collectively referred to as the "Parties."

1. Background

Section 4.1 of the Amended and Restated Franchise Agreement between the Agency and the Contractor dated October 19, 2020 ("Franchise Agreement") states in relevant part:

[I]f the terms and obligations contained in the Fourth Amendment to Agency Agreement #95-06 regarding 'Phase Two' of a Construction and Demolition Debris Program (CDP), or of another similar program that is reasonably satisfactory to the Agency, are not satisfied by June 30, 2025, Contractor shall repay to the Agency its payment for costs associated therewith in the amount of three hundred thousand dollars (\$300,000) no later than thirty (30) days after receiving notice from the Agency.

2. Purpose

The Parties acknowledge that the Contractor is in the process of transitioning the Clover Flat Sanitary Landfill site, sometimes referred to as the Clover Flat Resource Recovery Park located at 4380 Silverado Trail, Calistoga, CA 94515, toward closure and future operation as a transfer station. In light of this transition, the Parties wish to enter into this MOU to: (i) provide for "another similar program that is reasonably satisfactory to the Agency," as contemplated by Section 4.1 of the Franchise Agreement, and (ii) extend the deadline for implementing the program or repaying the Agency.

3. Use of Funds

The Parties reaffirm their intent that the \$300,000 shall be used for a project or projects at the Clover Flat Sanitary Landfill site that benefit the public. Notwithstanding anything to the contrary in the Franchise Agreement, the Contractor may use the funds for:

- Continuing, improving, or relocating recycling, composting, and similar programs that provide direct services to the public
- Site access improvements for the public to use the site for self-hauling of materials
- Weather protection infrastructure for public area
- Safety enhancements to separate public and commercial traffic
- Public-facing amenities
- Other projects at the site that benefit public access

4. Holding of Funds

The \$300,000 shall remain in the possession of the Contractor until applied to an approved project at the site or repaid to the Agency as provided in Paragraph 5. below.

5. Interest Accrual and Refund Obligation

If the Contractor has not spent at least \$300,000 on one or more projects identified in Paragraph 3. above by **June 30, 2025**, the \$300,000 shall begin to accrue interest at a rate of **4% per annum** starting **July 1, 2025**.

If the Contractor has not spent at least \$300,000 plus accrued interest on one or more projects identified in Paragraph 3. above by June March 31, 2028, the Contractor shall refund to the Agency the difference between actual monies spent on such projects and \$300,000 plus any accrued interest as provided herein.

If the Contractor has spent at least \$300,000 plus accrued interest on one or more projects identified in Paragraph 3. above by March 31, 2028, the Contractor's obligations under this MOU and the relevant provisions of Section 4.1 of the Agreement shall be satisfied.

6. Approval of Project

The Contractor shall submit a project proposal to the Agency for review and approval prior to commencement and the expenditure of any portion of the \$300,000 plus accrued interest (if any). Approval by the Agency's Board in advance is required for any project(s). The Agency's Board may approve or deny projects in its sole discretion.

7. Effect of MOU

This MOU only clarifies the Parties intent and obligations under the relevant provisions of Section 4.1 of the Franchise Agreement.

I will not be in attendance at today's meeting but I hope for the record that you will be able to state that I have submitted this Public Comment.

I am sharing with you my Comments that I submitted to to the San Francisco Regional Water Board last week on Aug. 13

These comments are also being shared with numerous other State agencies, as will be a recent National level LULAC Resolution on impacts to Latino Waste Workers with specific reference to Clover Flat Landfill/Upper Valley Disposal Service.

We continue to advocate at all levels and with all relevant Ca. public agencies for Public Hearings with sworn tesimony on these matters.

Public Comment from Geoff Ellsworth to the San Francisco Regional Water Board Wed. August 13th 2025

Please distribute to Board and Staff, thank you.

Good Morning Chair Strauss Hacker, Board and Staff, my name is Geoff Ellsworth Former Mayor of St. Helena, Napa County (2018-2022) now a member of California LULAC - the League of United Latin American Citizens and the Ca. LULAC Napa Valley Waste Workers Advisory Committee.

As I've spoken to here before there are significant concerns with long term impacts and lack of accountability to the primarily Latino workforce at Upper Valley Disposal Service/Clover Flat Landfill in Napa County including significant exposure to the toxic wastewater that is in your purview, as well as fires, unregulated radioactive waste and a Latino worker fatality.

I've just returned from the LULAC National conference in Southern California where a national level LULAC Resolution was adopted addressing this matter, including reference to additional Latino waste worker deaths in the San Francisco Bay Area since the beginning of just this year at other waste companies in the jurisdiction of the San Francisco Bay Area Regional Water Board. These recent deaths of Latino workers occurred at Recology in Brisbane and the ALCO scrap metal facility in San Leandro, both in the jurisdiction of the San Francisco Bay Area Regional Water Board, clearly indicating a systemic problem (see links below). I will provide the LULAC National level Resolution as it is finalized.

Our Ca. LULAC Waste Worker Advisory Committee has met on this issue as well with the Ca. Dept. of Labor and office of Ca. Assemblymember Liz Ortega of the 20th District that includes San Leandro and who has raised significant concerns regarding a breakdown of oversight on these matters.

We'll also be reaching out to the Assembly representative from the 21st District representing Brisbane and we are hearing from more Latino workers who point to systemic problems in reporting water and environmental contamination, workplace safety concerns and civil rights concerns.

These comments are also being provided to leadership at LULAC California and National leadership, as well

as to the Ca. State level Water Board and other relevant agencies.

The tragic deaths and the mistreatment of these Latino waste workers, including at Upper Valley Disposal Service/Clover Flat Landfill in Napa County, highlight a larger environmental problem when waste workers are untrained, fearful or unable to register complaints over mismanagement of toxic/contaminated and fire prone waste material that can escape into the broader environment and public waterways that are the purview of the Water Board.

In light of ongoing national events, the commitment to racial equity and protection of Civil Rights is up to all of us, and each of us, on a day to day basis on a board level, staff level and personal level, it's all of our responsibility.

The Water Board Racial Equity Action Plan combined with current state and federal laws as well as Water Board **Resolution 2021-0050** can be implemented towards addressing these systemic breakdowns. Again I ask this matter be agendized by this board and staff in hearings with sworn testimony at the soonest possible juncture.
