RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE TABLE AND INDEX OF CLASSES, AND APPROPRIATE PERSONNEL POLICIES, EFFECTIVE JUNE 20, 2026
