

Resume – Christopher Thompson

Christopher is a Firefighter with Napa County Fire Department, Deer Park Station, 21.

Christopher graduated from the Fire Academy in 2017 and was subsequently named Firefighting of the year, that same year. Christopher's status at Station 21 is a Driver Operator and is enrolled in an officer training program, with the training academy.

Christopher became President of the Board of the NCFF – Napa Community Firewise Foundation, or Napa Firewise, in 2019 and took the organization from a Board of 3, with a \$100,000 a year budget to now a Board of 15 with a budget of about \$10M a year. Christopher and his Board working in conjunction with the BOS assisted in the authorship of Measure L which was placed on the June Ballot. Christopher sits on the grants committee within the NCFF, and assisted in the authorship of a \$50M FEMA grant, as well as \$18M in various grants from CalFIRE, California Fire Safe Council, and Napa Community Foundation, all having been received under his administration.

Christopher is an advisory and retired member of the Board of Directors of the Frank Lloyd Wright Foundation, in Scottsdale AZ.

Christopher is self-employed and works as a consultant and electrical engineer, with projects throughout the world, and offices in the Bay Area and LA. He holds a BFA, and a BS in Electrical Engineering. He is an honorary member of the British Society of Interior Designers, and a member of the Illuminating Engineering Society of North America, as well as the International Association of Lighting Designers.
