SECOND AMENDMENT TO NAPA COUNTY AGREEMENT No. 210369B

THIS SECOND AMENDMENT to Agreement No. 210369B is made this day of March 2024, by and between the NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Innovative Interfaces Incorporated, a California corporation, whose mailing address is 789 E. Eisenhower Parkway, Ann Arbor, MI 48108, hereinafter referred to as "CONTRACTOR";

WHEREAS, on June 22, 2021, COUNTY engaged CONTRACTOR in Agreement 210369B (the "Agreement") for subscriptions to Envisionware and Polaris through Innovative Interfaces, which provides point of sale software, credit card swipes, self-check software integration and online ILS integration; and

WHEREAS, on December 19, 2023, COUNTY and CONTRACTOR amended the Agreement ("the First Amendment") to change the term. scope of work and pricing; and

WHEREAS, the Parties desire to further amend the Agreement as set forth in this Second Amendment.

NOW, THEREFORE, for good and valuable consideration and intending to be legally bound hereby, the parties hereby agree as follows.

- 1. Scope of Work. The Agreement is hereby amended to include additional services attached hereto as Exhibit "A-2" all references to Exhibit "A-1" shall be read Exhibit "A-2" as of the effective date of this amendment. .
- 2. Pricing Exhibit. This Agreement is amended to include a new pricing sheet attached hereto as Exhibit "B-2" all references to Exhibit "B-1" shall read Exhibit "B-2" as of the effective date of this contract. Further all previous references to Vega Premium Discover" as of the effective date of the Agreement shall now read "Vega Discover Consortia".

Except as otherwise amended hereby, the other provisions of the Agreement will remain in full force and effect as of the date hereof. In the event of a conflict between the provisions of this Addendum and the Agreement, the terms of this Addendum will control.
