RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, RESCINDING AND REPLACING RESOLUTION NO. 2026-75; AND REPLACING IT WITH EXHIBIT “A-1” ATTACHED HERETO EFFECTIVE JUNE 20, 2026

WHEREAS, Government Code section 25300 provides that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of county employees and that such action may be taken by ordinance or resolution; and

WHEREAS, section 2.100.270 of the Napa County Code provides that the “Table and Index” may be amended from time to time by resolution of the Board of Supervisors; and

WHEREAS, on June 23, 2026, the Board of Supervisors approved Resolution No. 2026-75 which deleted the incorrect classification of Mental Health Worker Aide; and

WHEREAS, the Chief Human Resources Officer recommends that the proposed changes to the Table and Index of Classifications in Exhibit “A” of Resolution No. 2026-75 be rescinded and replaced with Exhibit “A-1.”

NOW, THEREFORE, BE IT RESOLVED, that effective June 20, 2026, the Napa County Board of Supervisors hereby rescinds Exhibit “A” to Resolution No. 2026-75 and hereby approves the changes to the Table and Index of Classifications as set forth in Exhibit “A-1.”
