Resolution 2026-06 CALLING FOR TRUSTEE ELECTION IN NOVEMBER 2026 (Education Code Sections 5000, 5018, 5304, and 5322)

WHEREAS, the regular biennial election of Board of Trustee Members is ordered by law pursuant to Section 5000 of the Education Code to fill offices of Members of the Board of Trustees of Pope Valley Union Elementary School District, of Napa County, now be it

RESOLVED, THAT THE County Superintendent of Schools for this county call the election as ORDERED and in accordance with the designations contained in the following Specifications of the Election Order made under the authority of Education Code Sections 5304 and 5322.

SPECIFICATIONS OF THE ELECTION ORDER

The election shall be held on Tuesday, **November 3, 2026**.

Pope Valley Union Elementary School District's boundary lines have NOT changed.

The purpose of the election is to elect two (2) Members of the Board of Trustees of Pope Valley Union Elementary School District.

<u>Name of Current Incumbents</u>	<u>Term of Office to be Filled</u>
Brian Varner	4 Years (2026-2030)
Shasta Torrey	4 Years (2026-2030)

THE DISTRICT shall be responsible for the costs incurred by candidates in publishing a Statement of Qualifications of 200 words or less pursuant to Elections Code 11325 and 13307, including the cost of a Spanish translation, if such a statement and translation is requested by the candidates. The District will be billed for the costs along with other election costs.

Whenever a tie makes it impossible to determine which of two or more candidates has been elected to the Board, the Board shall immediately notify the candidates who received the tie votes of the time and place where the candidates or their representatives should appear before the Board. The Board at that time shall determine the winner by lot (Education Code 5016).

IT IS FURTHER ORDERED that the clerk or secretary of the district shall deliver not less than 123 days prior to the date set for the election, two (2) copies of this Resolution and Order to the Superintendent of Schools and one (1) copy to the officer conducting the election.
