## NAPA COUNTY AGREEMENT NO. 240001B AMENDMENT NO. 2

#### **PROFESSIONAL SERVICES AGREEMENT**

THIS AMENDMENT NO. 2 OF NAPA COUNTY AGREEMENT NO. 240001B is made and entered into as of this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2025, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and UNITED SITE SERVICES OF CALIFORNIA, INC., a California corporation, whose mailing address is 118 Flanders Road, Westborough, MA 01581, hereinafter referred to as "CONTRACTOR";

## RECITALS

**WHEREAS**, by Napa County Agreement No. 240001B entered into as of June 13, 2023, and effective July 1, 2023 (hereafter referred to as "Agreement"), CONTRACTOR agreed to provide portable restroom and sanitation services at various County locations; and

**WHEREAS**, on November 1, 2023, the COUNTY and CONTRACTOR entered into Amendment No. 1 to update the scope of work to include additional services at the Fire Training Grounds and increase maximum compensation to accommodate the need for additional routine services; and

**WHEREAS**, COUNTY and CONTRACTOR now desire to amend the Agreement to increase the maximum compensation for Fiscal Year 24/25 to accommodate the need for additional non-routine services.

## **TERMS**

**NOW, THEREFORE**, COUNTY and CONTRACTOR agree to amend the Agreement in accordance with the terms and conditions set forth herein as follows:

1. Exhibit "B-1" of the Agreement is rescinded and replaced in full by the document entitled Exhibit "B-2", incorporated herein, and all references in the Agreement to Exhibit "B" and "B-1" shall mean Exhibit "B-2".

2. Paragraph 3, "Compensation" is hereby amended to read in full as follows:

## 3. Compensation.

(a) <u>Rates.</u> In consideration of CONTRACTOR's fulfillment of the promised work, COUNTY shall pay CONTRACTOR at the rates set forth in Exhibit "B-2" attached hereto and incorporated by reference herein.

(b) <u>Expenses.</u> No travel or other expenses will be reimbursed by COUNTY.

(c) <u>Maximum Amount.</u> Notwithstanding subparagraphs (a) and (b), the

maximum payments under this Agreement shall be as set forth below; provided, however,

that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered and reimbursable expenses actually incurred.

3. **Counterparts.** This Amendment No. 2 may be executed in counterparts, which when taken together, shall constitute a single signed original as though all parties had executed the same page.

4. **Electronic Signatures.** This Amendment No. 2 may be executed by electronic signature(s) and transmitted in a portable document format ("PDF") version by email and such electronic signature(s) shall be deemed original for purposes of this Amendment No. 2 and shall have the same force and effect as a manually executed original.

5. This Amendment No. 2 shall be effective as of January 15, 2025.

6. Except as provided in paragraphs 1 through 5 above, the terms and provisions of the Agreement shall remain in full force and effect.

## **County Wide:**

<u>Routine Services</u>: Contract includes up to \$9,000 per fiscal year for fiscal year 23/24, 24/25, and 25/26 and \$9,500 per fiscal year in fiscal years 26/27 and 27/28 for routine services provided County Wide at the rates listed in this Exhibit "B-2".

Non-Routine, On-Call/Emergency Services: Contract includes up to \$3,000 in fiscal year 23/24, \$53,000 in fiscal year 24/25, \$3,000 in fiscal year 25/26, and \$3,500 per fiscal year in fiscal years 26/27 and 27/28 for non-routine, on-call/emergency services provided County Wide at the rates listed in this Exhibit "B-2".

## **County Fire:**

<u>Routine Services:</u> Contract includes up to \$12,000 per fiscal year in fiscal years 23/24, 24/25, and 25/26 and \$12,500 per fiscal year in fiscal years 26/27 and 27/28 for routine services provided to County Fire Department at the rates listed in this Exhibit "B-2".

<u>Non-Routine, On-Call/Emergency Services:</u> Contract includes up to \$5,000 per fiscal year in fiscal years 23/24, 24/25, and 25/26 and \$5,800 per fiscal year in years 26/27 and 27/28 for non-routine, on-call/emergency services provided County Fire Department at the rates listed in this Exhibit "B-2".
