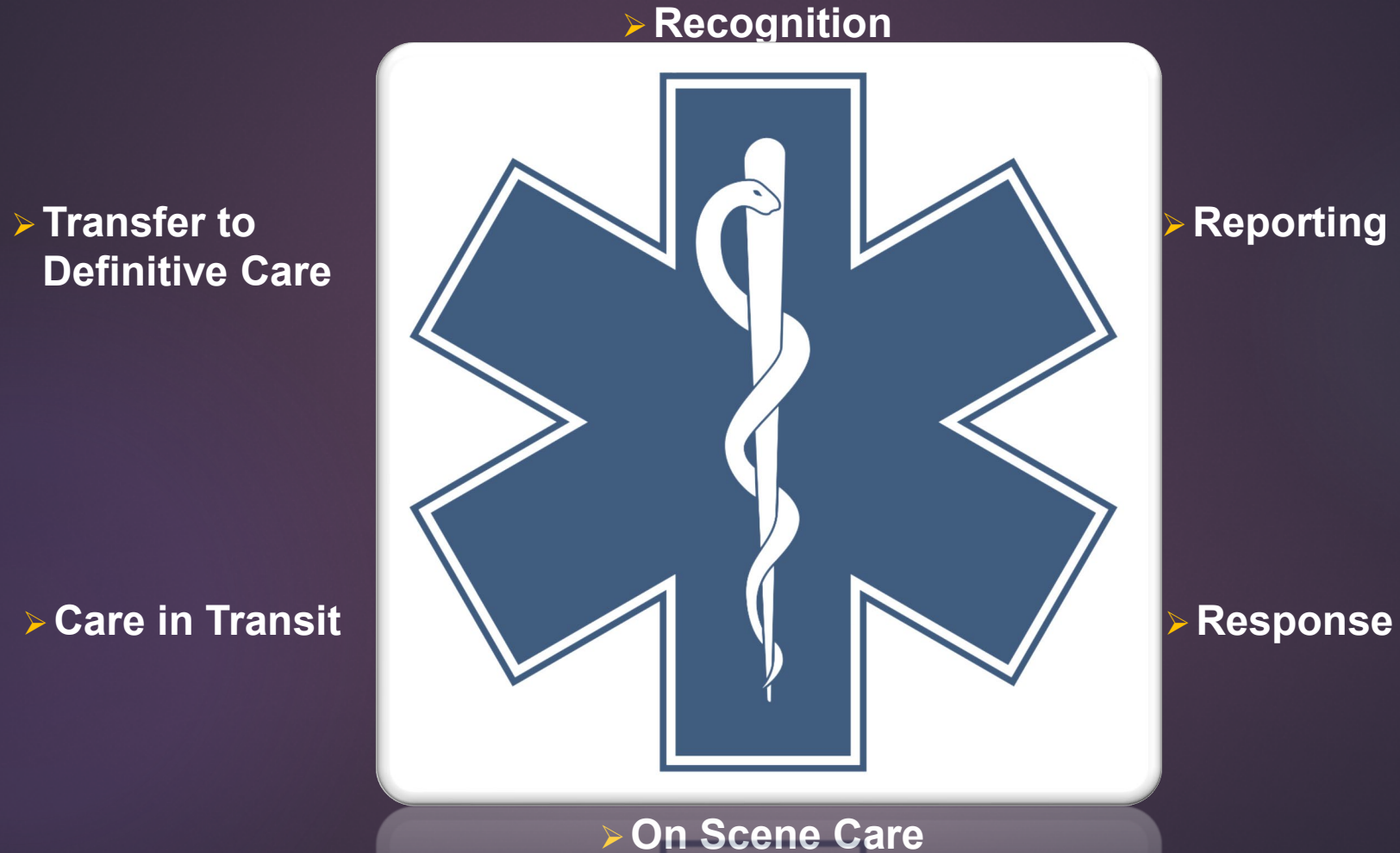

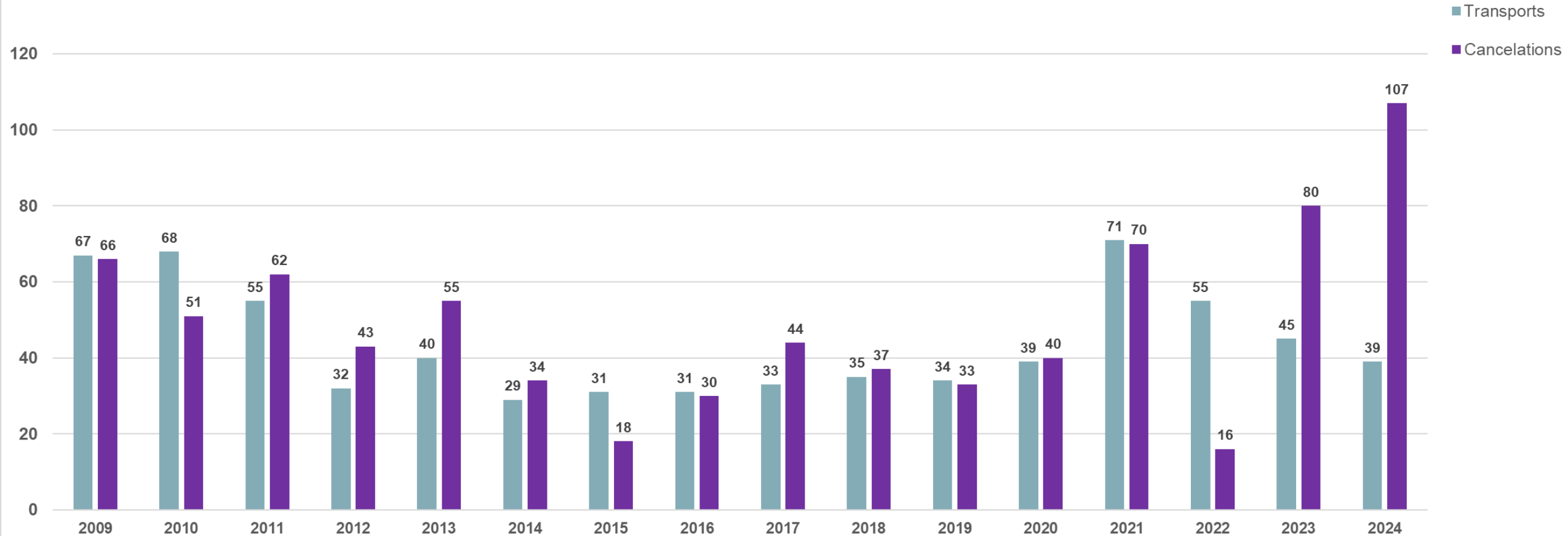

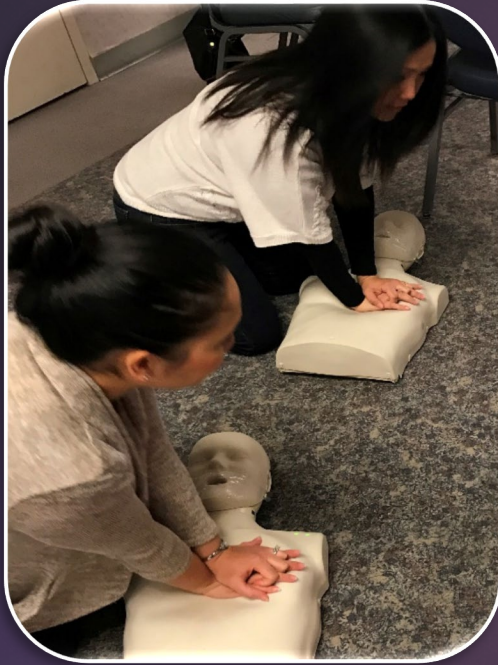

2009 - 2024**

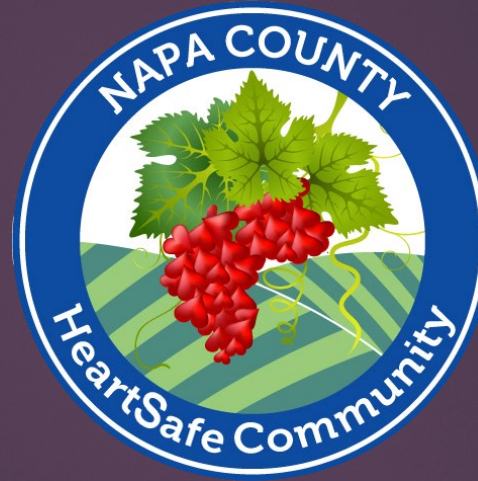

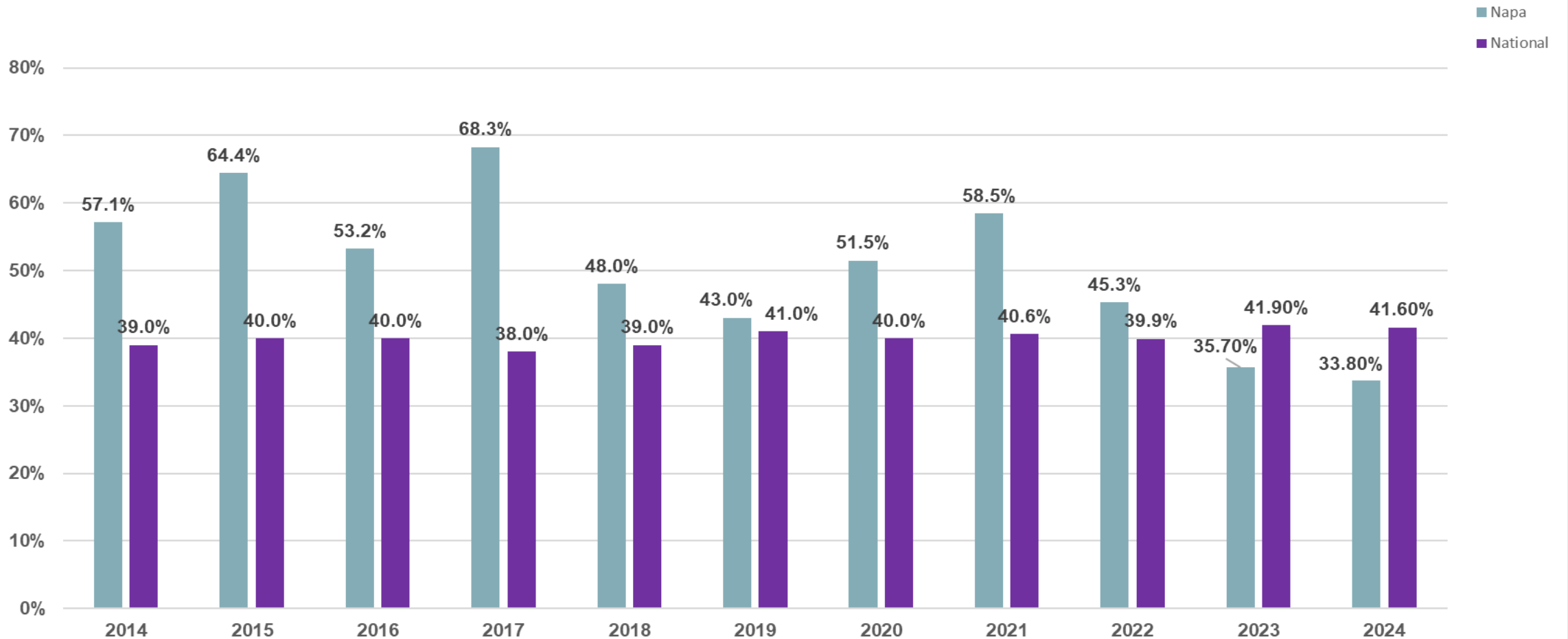

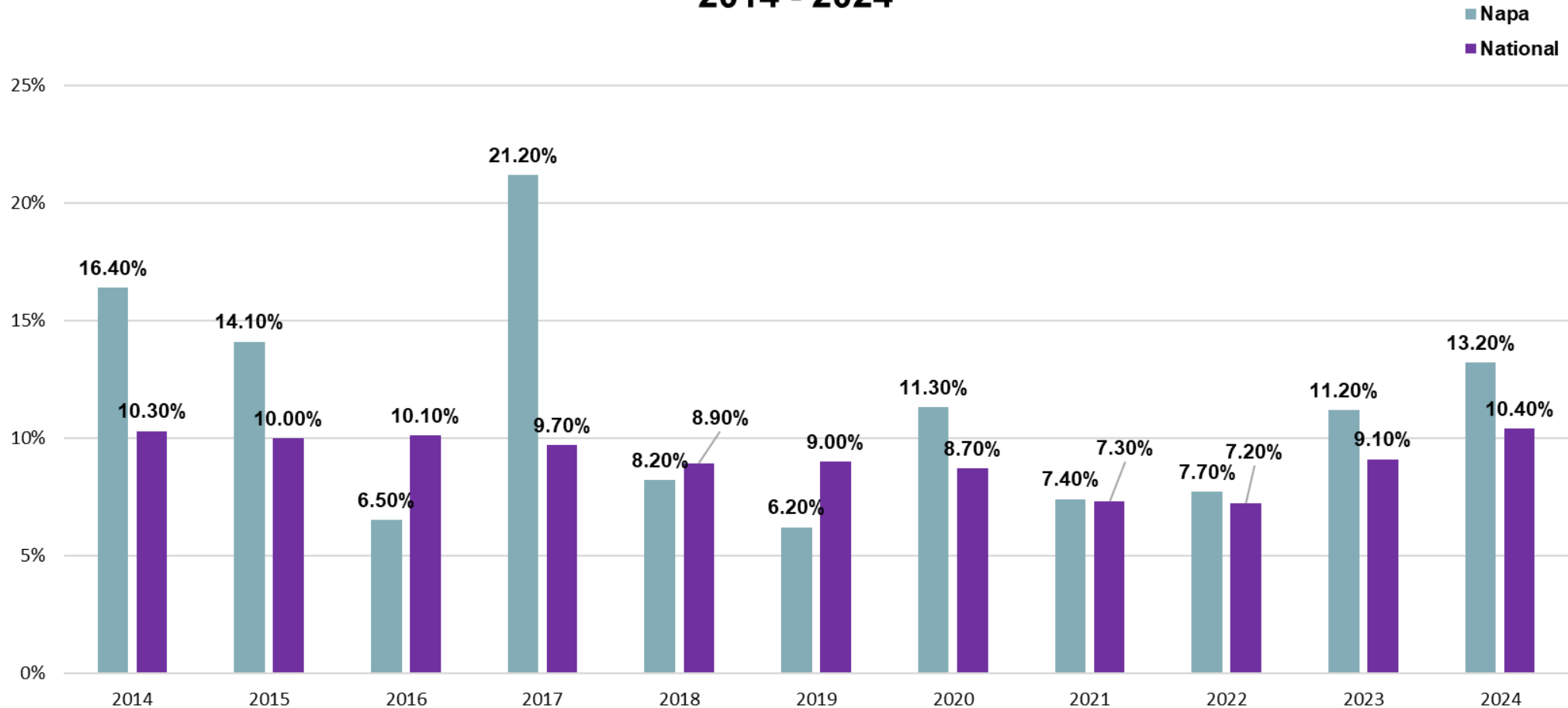
Cardiac Arrest Survival

Bystander CPR 2014 - 2024

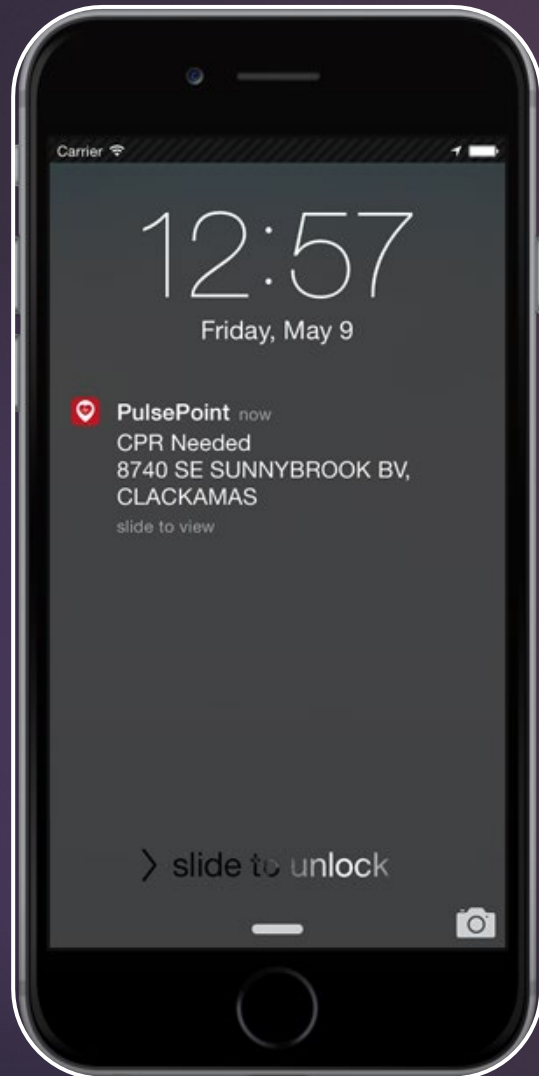


Cardiac Arrest Survival

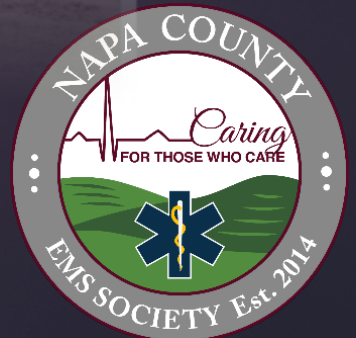

Accomplishments for 2024

- The Napa County Public Information and Education team integrated Stop-The-Bleed and Naloxone administration training in partnership with the QVMC Trauma Program and the Napa Opioid Safety Coalition.
- Expanded CPR in school programs from 9th grade- to now include 5th grade and 7th grade.
- Expanded AED placement to Napa County Sheriffs and American Canyon Police Department.

EMCC Goals for 2025

- Continue to identify (all) AED locations in Napa County
- Expand the scope of PIE to include:
 - Stop-the-Bleed messaging
 - Public access Nasal Narcan utilization
- Educate our community members in Hands Only CPR and use of an AED
 - Continue event-based training and seek other avenues for outreach during this challenging year
- Collaborate with key community partners to encourage successful designation as a HeartSafe Community
 - St. Helena

 - Yountville

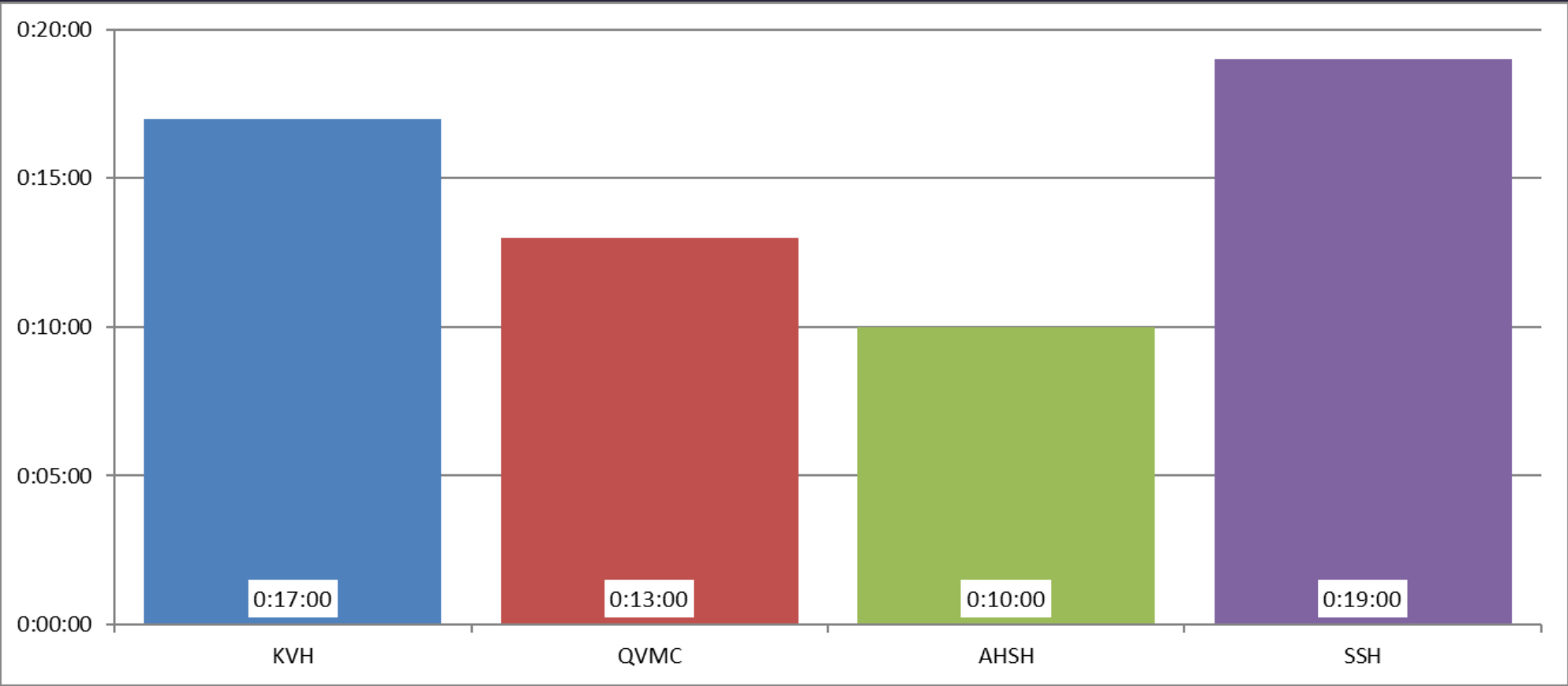

- THE AMERICAN MEDICAL RESPONSE CONTRACT WAS APPROVED BY THE NAPA COUNTY BOARD OF SUPERVISORS ON SEPTEMBER 14, 2021 AND OPERATIONS COMMENCED ON DECEMBER 31, 2021.

- AMR MET ALL COMPLIANCE REQUIREMENTS IN CALENDAR YEAR 2024.
- CONTRACT CALLS RESPONSE TIME COMPLIANCE.
 - AMR RESPONDED ON TIME TO 95.12% OF 17,377 CONTRACTED REQUESTS FOR SERVICE IN 2024.

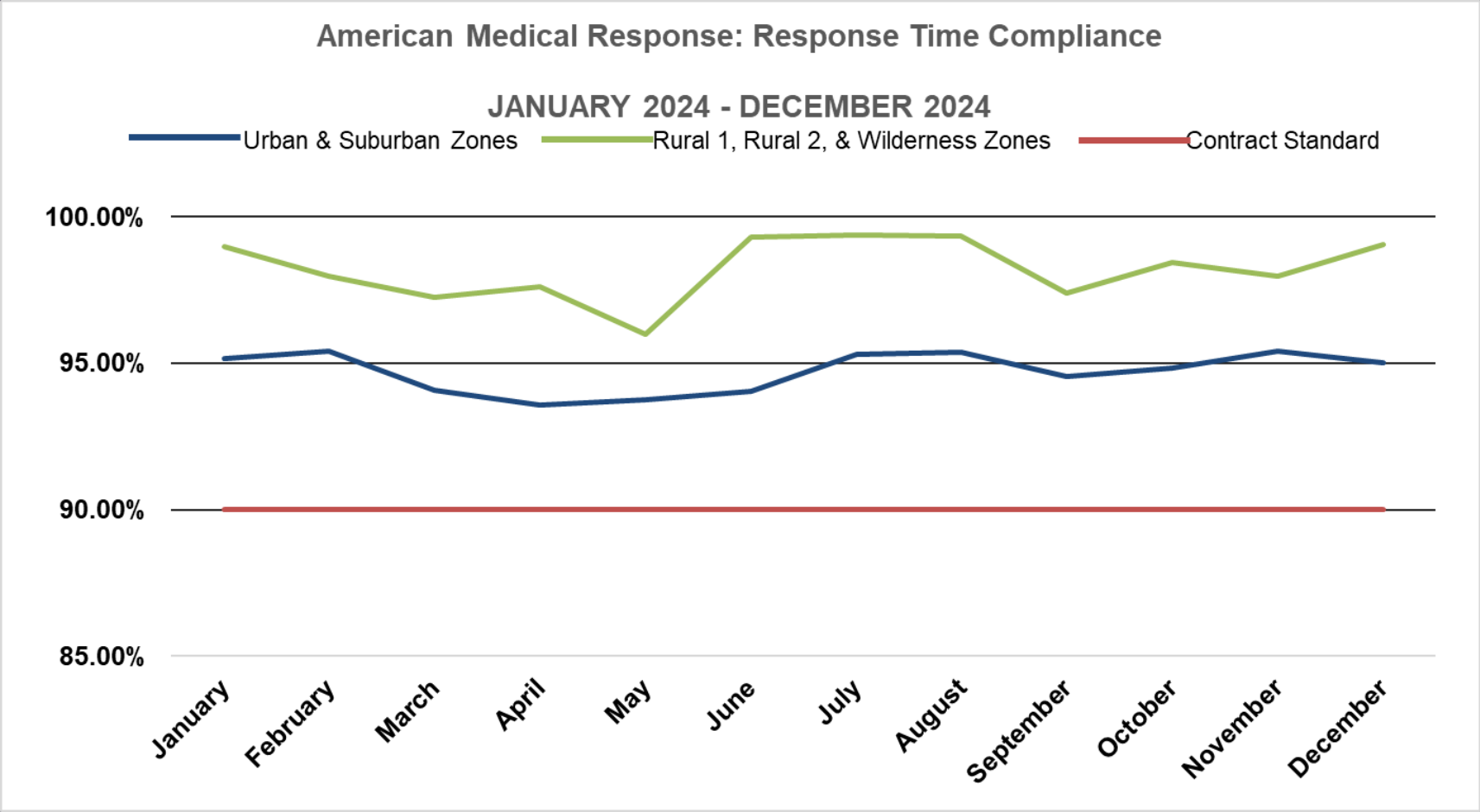

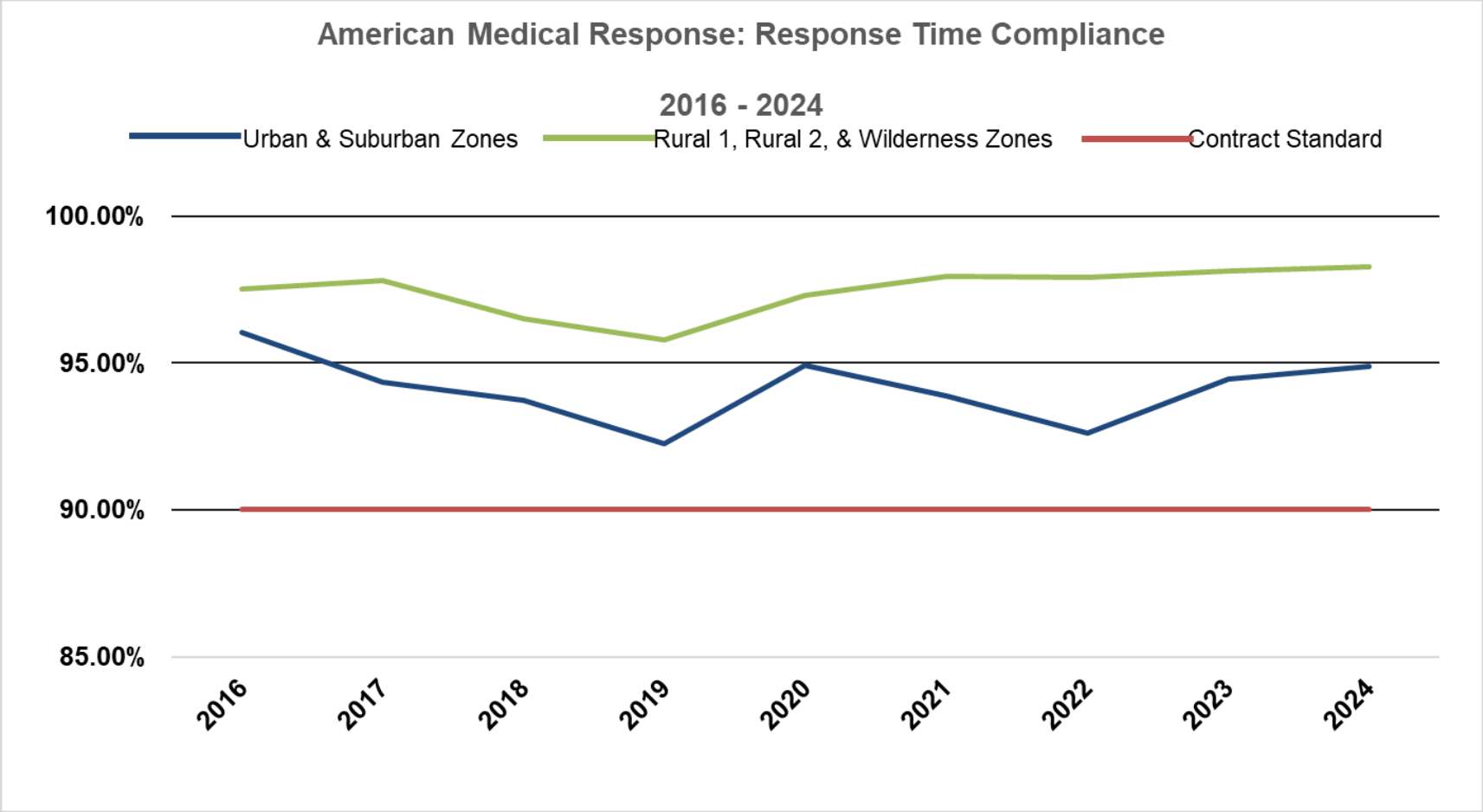

CLINICAL METRICS



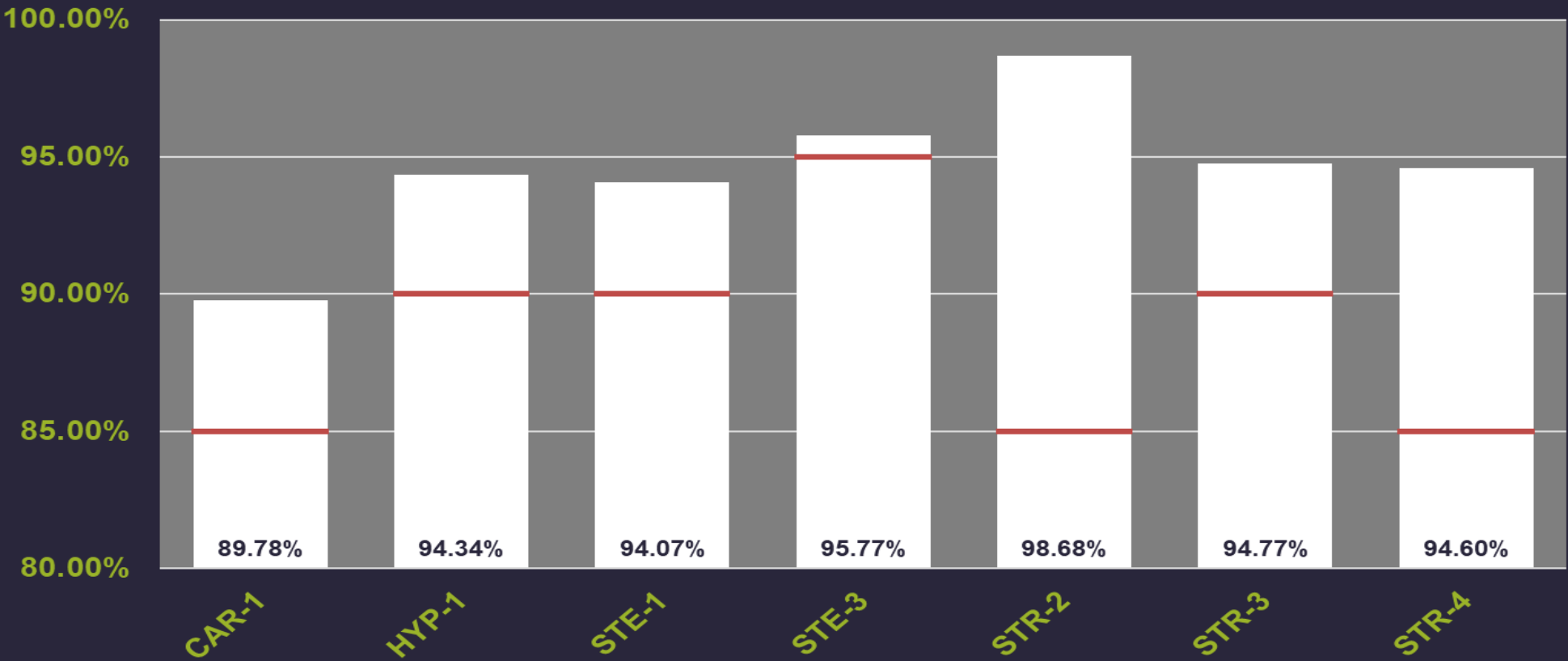
1. **CAR-1:** ETCO2 MEASURED ON ALL NON-TRAUMATIC CARDIAC ARRESTS **85%**
2. **HYP-1:** TREATMENT OF HYPOGLYCEMIA ON MEASURED BGL <60 mg/dL **90%**
3. **STE-1:** 12-LEAD ECG PERFORMED IN SUSPECTED CARDIAC PATIENTS **90%**
4. **STE-3:** ASPIRIN ADMINISTRATION FOR SUSPECTED STEMI **95%**
5. **STR-2:** LAST KNOWN WELL TIME (LKWT) FOR SUSPECTED STROKE **85%**
6. **STR-3:** BLOOD GLUCOSE LEVEL OBTAINED FOR SUSPECTED STROKE **90%**
7. **STR-4:** PRE-ARRIVAL STROKE ALERT ON PATIENTS WITH A POSITIVE STROKE SCREEN **85%**
