## RESOLUTION OF THE GOVERNING BOARD OF THE NAPA BERRYESSA RESORT IMPROVEMENT DISTRICT, ESTABLISHING THE APPROPRIATIONS LIMIT FOR THE DISTRICT FOR THE 2023-2024 FISCAL YEAR

**WHEREAS**, Article XIIIB of the California Constitution requires each entity of local government to annually establish an appropriations limit; and

**WHEREAS**, the annual appropriations limit generally cannot exceed the entity's appropriations limit for the prior year as adjusted for the change in the cost of living and the change in population, except as otherwise provided in Article XIIIB; and

WHEREAS, section 8(e)(2) of Article XIIIB requires local governmental entities to select by a recorded vote of their respective governing bodies the methodology for determining the change in the cost-of-living factor, either the percentage change in California per capita personal income from the preceding year or the percentage change in the local assessment roll from the preceding year due to the addition of local non-residential new construction;

**NOW, THEREFORE, BE IT RESOLVED** by the governing board of the Napa Berryessa Resort Improvement District ("District") that the appropriations limit and the estimated revenues subject to the limit for the District for fiscal year 2023-2024 are as follows:
