

## NINTH AMENDMENT TO NAPA COUNTY AGREEMENT NO. 4529

**THIS NINTH AMENDMENT** is made effective April 22, 2025, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and Back Street Fitness, Inc., doing business as HealthQuest Fitness Center, a California corporation, whose mailing address is 3175 California Boulevard, Napa, California, 94558, hereinafter referred to as "CONTRACTOR."

### RECITALS

**WHEREAS**, on July 31<sup>st</sup>, 2001, COUNTY engaged CONTRACTOR in Agreement No. 4529 to provide certain services to the COUNTY; and

**WHEREAS**, COUNTY and CONTRACTOR wish to amend Agreement No. 4529 to make changes to the provision for compensation, as follows:

### TERMS

**NOW, THEREFORE**, COUNTY and CONTRACTOR hereby amend Agreement 4529 in accordance with the terms and conditions set forth herein:

As of the effective date of the Amendment Paragraph 1 Compensation shall now read:

1. **Compensation.**

(a) Rates. Paragraph 3 of Exhibit A of the Agreement is amended to read in full as follows:

Corporate Program Compensation. For those employees and their dependents who wish to participate in the Corporate Fitness Program through payroll deductions, the COUNTY shall pay CONTRACTOR as follows:

**Employee Only:** Seventy-Nine Dollars (\$79.00) per month

**Family (couple)\*:** One Hundred Thirty-Seven Dollars (\$137.00) per month

**Additional Family Member:** Fifty-Eight Dollars (\$58.00) per month


All County employees and family members who enroll for membership with HealthQuest will be required to sign and comply with the terms and conditions in the HealthQuest membership agreement.

\*Must reside at same address.

2. All other terms and conditions of Agreement No. 4529, and any written Amendment not consistent with this Amendment, shall remain in full force and effect.
