**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS,
STATE OF CALIFORNIA, FOR FUNDING THE RESTITUTION PROGRAM BY
THE CALIFORNIA VICTIM COMPENSATION BOARD**

WHEREAS, the Napa County District Attorney’s Office has operated a certain project designated THE CRIMINIAL RESTITUTION COMPACT (hereinafter referred to as “Program”) since 1998 with the State of California Victim Compensation and Government Claims Boards, now renamed the California Victim Compensation Boards as a result of Senate Bill 836 (hereinafter referred to as “CalVCB”); and

WHEREAS, the Napa County District Attorney’s Office desires to continue the Program, which provides funding toward a Victim Restitution Specialist, through a Standard Agreement (hereinafter referred to as “Standard Agreement”) for each fiscal year with the CalVCB, which expired on June 30, 2026 and will be renewed following the adoption of this resolution, to ensure restitution fines and orders are properly administered in accordance with applicable statutes; and

WHEREAS, the CalVCB has authorized and allocated \$55,000 per fiscal year, for a maximum of \$165,000, for the period of July 1, 2026 through June 30, 2029 for the District Attorney’s Office to continue to operate the Program, subject to the execution of a Standard Agreement and acknowledgement of the terms and conditions contained therein;

NOW, THEREFORE, BE IT RESOLVED by the Napa County Board of Supervisors as follows:

1. The Board of Supervisors authorizes the Napa County District Attorney to execute a Standard Agreement and submit any necessary documents associated therewith to the CalVCB for the purpose of continuing the Program for the period beginning July 1, 2026, and ending June 30, 2029, including any extensions or amendments thereof, and for each fiscal year thereafter as funding continues to be available for the program.
