RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS
AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO SIGN THE
PROGRAM SUPPLEMENT AGREEMENT FOR THE HIGHWAY SAFETY
IMPROVEMENT PROJECT TO INSTALL INTERSECTION IMPROVEMENTS
AT THREE LOCATIONS ON SILVERADO TRAIL

**WHEREAS**, on May 9, 2022, Caltrans issued a call for projects to cities and counties to apply for funding for projects to improve safety along local streets and roads; and

**WHEREAS**, on September 9, 2022, the County submitted to Caltrans an application under the Cycle 11 Highway Safety Improvement Program to install intersection improvements at three locations on Silverado Trail; and

WHEREAS, on March 9, 2023, Caltrans notified the County of the selection of the Highway Safety Improvement Program projects into the program with eligibility for Highway Safety Improvement Program funds (90% Federally Funded) with a 10% local match; and

**WHEREAS**, on March 9, 2023, Caltrans notified the County that State funds will be used for the Highway Safety Improvement Program Cycle 11 project for intersection improvements on Silverado Trail; and

**WHEREAS**, on October 24, 2023, Caltrans authorized the County's Request for Authorization to proceed with Preliminary Engineering (E-76) for intersection improvements on Silverado Trail at the Strawberry Patch, Oak Knoll Avenue, and Zinfandel Lane for the HSIPL-5921(090) project;

**WHEREAS**, on October 24, 2023, Caltrans issued Program Supplement Agreement No. 00000A318 for the HSIP Cycle 11 Silverado Trail Intersection Improvements, RDS 22-26 (HSIPL-5921(090)) project; and

**WHEREAS**, the Caltrans' grant application procedures require, among other things, an Applicant's governing body to declare by Resolution certain authorizations related to the execution of the program supplement agreements;

**NOW, THEREFORE, BE IT RESOLVED** by the Napa County Board of Supervisors as follows:

- 1. The foregoing recitals are true and correct.
- 2. The Director of Public Works or designee thereof is hereby authorized to submit the Program Supplement Agreements to Caltrans for all grants for which Napa County is eligible.
- 3. The Director of Public Works or designee thereof is hereby authorized to and empowered to execute in the name of Napa County all grant documents, including but not limited to, applications, agreements, amendments, and requests for payment, necessary to secure grant funds and implement the approved grant projects.
