Dear Napa County Fire Department,

On behalf of the Deer Park Firefighters Association and Community friends, we are pleased to donate a Utility Terrain Vehicle (UTV) and accompanying trailer to the Napa County Fire Department for rescue and emergency operations in support of the Citizens and visitors in Napa County.

Over the last several years the number of people getting out and exploring the trails in the County has increased tremendously. With this uptick of those finding solitude in nature and enjoying themselves, it has increased the frequency of those getting injured and lost that may not have been properly prepared, requiring a call to 9-1-1.

Most of these calls happen in remote and difficult to reach areas that cannot be reached by normal emergency vehicles and are miles away from pavement. Use of other Search and Rescue services by the Sheriff Dept is available but comes with a time penalty for gathering those resources together and to the scene. The use of Rescue Helicopters is often used but with it comes a high degree of risk, especially at night. In some incidents, use of aircraft may not be justified due to the reported nature of the call but is the only thing available due to access and extended response time for rescuers to hike in. Many times, aircraft are not available, delayed or unable to respond due to inclement weather conditions. Other UTV's exist in the system but may not be available for immediate use or easily moved to incidents and emergency operations..

With a dedicated UTV on a trailer at St. Helena Calfire Station and ready for emergency response by Napa County Fire personnel, this asset can be used as a front line response vehicle to decrease the time reaching patients. In addition to rescue operations, this vehicle can also be used to move first responders in remote areas of Napa County for fire suppression activities for wildland and structure fires along with other natural disasters and uses in times of emergency.

We thank you for taking the time to work with the Association and look forward to using this donated equipment in the coming years to help the citizens in Napa County!
