RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE DEPARTMENTAL ALLOCATION LIST FOR THE DEPARTMENT OF CORRECTIONS, EFFECTIVE FEBRUARY 18, 2023
