#### 8. BOARD OF SUPERVISORS REPORTS AND ANNOUNCEMENTS

Vice-Chair Anne Cottrell reported on recent meetings and conversations with small/prewinery definition ordinance wineries on the challenges they face with obtaining or amending a use permit and would like an update from staff by the end of the year on the goals and results of the County's small winery and use modification, compliance, and micro-winery programs. Vice-Chair Cottrell also reported on a site visit of the Toll Fire near Calistoga last week and thanked Napa County Fire Chief Brian Hamm. She noticed County firefighters and several volunteer engines onsite, which is important due to the lack of hydrants and water tanks in the area. Vice-Chair Cottrell mentioned the updating of the agreement between the County and volunteer firefighters and underscored the goal of recognizing their value and to retain strong volunteers and increase those numbers, as well as provide ongoing opportunities for their input. Not only do they respond to locations all over the valley, but they provide a connection to the community and are a source of local knowledge that is critical in a large event. Vice-Chair Cottrell thanked the Fire Administration team for their role in updating the agreement.

Assessor-Recorder/County Clerk John Tuteur reported the assessment roll for the 2024-25 tax year was finished. The total value is \$55.2 billion, which includes an increase of \$2.4 billion, or 4.59%, from last year's value. Napa County has the fourth highest per capita assessment roll in the state following Marin, San Francisco, and San Mateo Counties. Mr. Tuteur suggested property owners compare their values from last year so that they have an opportunity between now and November to contact the Assessor's office with any questions or concerns.

#### Discussion held.

Supervisor Belia Ramos requested the County Executive Officer bring back a workshop to better understand the advantages and disadvantages of the County's project labor agreements and for the Board to consider as they relate to the upcoming facilities master plan. Several jurisdictions withing the county, most recently American Canyon, have adopted their own project labor agreement policies and ordinances, and the last time Napa County had a large capital improvement project, this subject was reviewed only in a limited budgetary sense and not at a broader level.
