7. BOARD OF SUPERVISORS REPORTS AND ANNOUNCEMENTS

Vice-Chair Liz Alessio reported on her attendance at the National Association of Counties (NACo) Legislative Conference in Washington DC and thanked Legislative and Policy Analyst Andrew Mize for his organizational and planning work as well as Supervisors Anne Cottrell and Belia Ramos for their continued showcase of leadership and Director Steve Lederer for his expertise. Vice-Chair Alessio mentioned that California State Association of Counties (CSAC) invited her to be the Vice-Chair of the Childcare Committee. Next, she reported on her attendance at an event to discuss Congressman Mike Thompson's American Affordability Act. She thanked Board Aide Leah Doyle-Stevens, and Fire Administrator J.R. Rogers for putting together the annual Napa County Fire Appreciation Dinner. Lastly, Vice-Chair Alessio provided comments on the Queen of the Valley Medical Center potential sale negotiations.

Supervisor Anne Cottrell reported on her experience at NACo Legislative Conference. During her time there she chaired a Resilient Counties Innovation Council meeting where they discussed emergency response, community recovery, and flood resilience. Next, she mentions that Supervisor Joelle Gallagher, the Napa Valley Vintners, Director of Housing and Community Services Jennifer Palmer, and Legislative and Policy Analyst Andrew Mize, joined her for a day of State advocacy to support a farmworker housing bill. Next, Supervisor Cottrell thanked Caltrans for their work on the current roadwork taking place within District 3.

Director Belia Ramos reported on her attendance at NACo Legislative Conference and being a representative of the Justice and Public Safety Committee where they received an update on the Department of Homeland Security. She encouraged the public to get involved in the General Plan through input in the Baseline Data Report (BDR). There will be a town hall meeting on March 19, 2026 from 10:30am-12:30pm at Schmidt Hall in Yountville and online on March 23, 2026 from 4:30pm-6:00pm via Zoom (Registration required). Supervisor Ramos mentioned her attendance at the CSAC Challenge Awards. Next, the American Canyon Chamber hosted an annual city luncheon where they allowed Supervisor Ramos to present a "state of the County" update. She then encouraged the Board to familiarize themselves with the updates from CSAC regarding HR1 and its impact to California. Next, Supervisor Ramos reported on her attendance and participation at the Napa Valley Transportation Authority (NVTa) meeting where she sat as the alternate representative to Supervisor Liz Alessio and stated that American Canyon has abandoned the roundabout model on Highway 29 and have decided to go with the synchronization of signals method. Next, Supervisor Ramos reported on touring the NorthBay Health Primary and Urgent Care facility in American Canyon. Lastly, Supervisor Ramos thanked everyone who was involved in the success of the annual Napa County Fire Appreciation Dinner. She then made a referral to the Chief Executive Officer to reorganize budget amendments on the meeting agenda as well as the creation of a workshop to discuss Capital Improvements.

Supervisor Joelle Gallagher thanked everyone involved for the annual Napa County Fire Appreciation Dinner. She also expressed her enjoyment with the Napa Valley Vintners group during their State Advocacy work. Next, she congratulated the Health and Human Services Agency on their acknowledgement by Governor Gavin Newsome receiving the Cares Champion award for CARE Court. Lastly, Supervisor Gallagher requested staff work with sponsors to provide a presentation on the Napa County Wildfire Preparedness, Watershed Protection, and Open Space Preservation Act.

Chair Amber Manfree announced that Napa County is hiring Vote Center Workers for the June and September Statewide Elections. She is looking forward to the Napa Climate Now Summit on March 26, 2026 at Napa Valley College Performing Arts Center. Also, Chair Manfree attended the Community Wildfire Protection Plan meeting in Circle Oaks and thanked Capell valley for hosting both the referenced meeting and another in Silverado. Next, there is an upcoming community event on March 20, 2026 at the Copia with a speech on Urban ecology from Dr. Christopher J. Schell. Supervisor Manfree noted her attendance at Civic Well from March 12-14 and will provide a report to the Board thereafter. Lastly, Chair Manfree suggested attendance at the Recycling Awards on March 19, 2026.
