### **RECOMMENDATION**

Approve a report of emergency Public Works actions on a project to repair airport runway lighting as authorized by Resolution No. 2015-37, determine that the emergency does not permit the delay associated with competitive bidding procedures, and that the emergency actions are necessary to respond to the emergency pursuant to Public Contract Code Section 22050(c)(1) and affirm the need to continue this action. (No Fiscal Impact)

### **BACKGROUND**

Per Public Contract Code section 22050(c)(1), when expedited contracting procedures are used, the Board shall review the emergency action at its next meeting and at every regularly scheduled meeting thereafter (but not more often than every 14 days) until the action is terminated, to determine, by a four-fifths vote, that there is a need to continue the action.

#### **Project: Airport Runway 6-24 End lighting repairs (\$137,100)**

A transient jet aircraft departed Runway 24 at max power, causing several large pavement pieces of the blast pad and two of the eight Runway threshold lights to dislodge into the Runway Safety Area, exposing sections of live high-voltage electrical cable, potentially fatal to people and wildlife near it. Airport Operations immediately secured the electrical circuit to the threshold lighting systems, issued proper notices to the Federal Aviation Administration (FAA) and began to repair the blast pad area where they could.

Runway threshold lights mark the beginning of the usable runway for landing. From the opposite direction, these same lights appear red to signal the end of the runway for landed aircraft. This lighting system is required for Airports with instrument approaches and for all aircraft operating in inclement weather. Inoperable lights require FAA notice to airman of non-standard lighting and limits to Runway night operations. Threshold lights are required for safe landing on Runways during nighttime operations and result in closures in inclement weather if not operational.

Our Airfield Lighting contractor, Royal Electric, was called out to assess the system and determined there was

no way to repair the edge lighting original to the 1940's era Runway with high voltage electrical cables directly buried in the ground without conduits or safety measures. The FAA requires prompt attention to closure repairs by the Airport Sponsor, in this case Napa County, under Advisory Circulars AC 150/5345-46E and 150/5340-26C.

Airport Staff worked with our Aviation Engineering experts, Mead & Hunt, on design elements to bring Runway 24 threshold lighting system into current FAA standards. Airport staff then requested informal bid proposals from Vellutini Corporation dba: Royal Electric Co and St. Francis Electric based on the design and specifications through Mead & Hunt. Royal Electric provided a bid for \$137,100 and could meet the emergent timeframes to make the system operational. St. Francis provided a quote significantly higher at \$251,710.

**Status:** The Emergency contract with Royal Electric was signed on 10/24/25, and the contractor has commenced ordering materials to conduct the repair.

Approve the above report and affirm that the project should continue under the expedited contract.

(Fiscal Impact: \$1,000,000 Expense; General Fund-Tobacco Settlement; Not Budgeted; Discretionary)

**BACKGROUND**

States have been notified of impending disruption to Supplemental Nutrition Assistance Program (SNAP) benefits - known as CalFresh in California - effective, Saturday November 1. This crisis stands to impact millions of Americans and over 5.5 million low-income Californians who will be cut off from these benefits. Each month California issues approximately \$1.1 billion in federal CalFresh benefits to eligible residents to purchase food. The CalFresh program is one of California's largest social safety net programs and is regarded as one of the most effective tools to combat poverty and food insecurity.

In Napa County, approximately 6,600 households and 10,700 residents rely upon CalFresh benefits to feed themselves and their families and the total monthly distribution amounts to approximately \$1.9 million. Being cut off from these benefits leaves Napa County households and residents - over 60% of whom are children and older adults - without the ability to purchase food. Put another way, CalFresh benefits are a lifeline for 1 in

every 12.5 residents in Napa County.

When access to food benefits is cut off, there is a direct negative impact on the lives of our residents that worsens hunger and physical health, increases financial hardship, and causes undue stress. More broadly, there is a ripple effect on the local economy through revenue losses, an increase in food insecurity, higher demand placed on the emergency food system, and a negative impact on community health.

That background in mind, the request before the Board for approval is to utilize Tobacco Master Settlement Agreement (MSA) funds to mitigate the detrimental impacts to residents who rely upon these essential benefits. The funds will be used to provide a concrete resource to CalFresh households so they can purchase food for themselves and their families through grocery store gift cards that approximate the experience of using CalFresh EBT cards. Napa Valley Community Foundation (NVCF) has agreed to provide the backbone support necessary to operationalize a distribution of this magnitude through a network of community-based providers who are trusted messengers, and who have deep partnerships with HHS who will work in tandem to support this rollout and needed program verifications.

The County receives proceeds annually from the National Tobacco Master Settlement Agreement and designates the monies for community health assistance grants. The reserves totaled \$7.8 million on July 1, 2025 and are projected to total \$6.6 million at the end of the fiscal year per the adopted budget. Additional draws will reduce the reserves to an amount ranging from \$5.6-\$6.6 million.

The County has an over two decades long history of designating MSA funds specifically for community health. Using MSA funds for this purpose also builds upon the connection strategically made between MSA funds and our Community Health Improvement Plan (CHIP) in the current grant cycle that runs from Fiscal Year 24/25 through 26/27. Specifically, this planned one-time use of MSA funds for emergency food assistance furthers our CHIP priority area of “Economic Stability” and the strategy to “Increase access to fresh, nutritious, and culturally and/or medically appropriate food for low-income and Latine residents.”

Additionally, using MSA funds to support our residents who are lower-income and have qualified and rely upon CalFresh benefits aligns with goals in the County’s Strategic Initiatives 2025-2030 recently approved by the Board. Specifically, under Build Healthy, Connected Communities:

“We will foster inclusive, connected, and *responsive communities* by *advancing liability, mobility, and accessibility* - creating welcoming, opportunity-rich places *that adapt to the evolving needs of all people, especially those most vulnerable.*”

“*Strengthen equitable access* to core services and *opportunities that protect health, safety and wellbeing.*”

The Resolution before the Board aims to address the evolving needs of our most vulnerable residents by adapting the County’s budget policy guideline to work for CalFresh recipients who will suddenly find themselves cut off from a lifeline. These are households and individuals who have done everything that the government asked of them to qualify for these benefits. They remain eligible for them. They simply cannot access them at this time. As this is a fluid situation that has quickly emerged and information may change at any point, the attached Resolution provides the necessary flexibility and time to finalize the execution of a contract

within parameters approved by the Board.

Requested Actions:

1. Adopt a Resolution to temporarily suspend the County’s approved Budget Policy Guidelines and allow for partial backfill of a food assistance program for qualified CalFresh recipients and to authorize Director of Health and Human Services Agency to sign an agreement with Napa Valley Community Foundation to fund the assistance for \$500,000 per month for two months through December 31, 2025 unless State or Federal funding is restored; and
2. Approve a Budget Amendment to increase General Fund-Tobacco Settlement Support and Care of Persons Expense (1055000-53500) totaling \$1,000,000 from Assigned Fund Balance.

**RESOLUTION OF THE BOARD OF SUPERVISORS OF NAPA COUNTY,  
STATE OF CALIFORNIA, AUTHORIZING THE DIRECTOR OF NAPA  
COUNTY HEALTH AND HUMAN SERVICES AGENCY TO ENTER  
INTO A CONTRACT WITH NAPA VALLEY COMMUNITY  
FOUNDATION (“FOUNDATION”) TO PROVIDE EMERGENCY FOOD  
ASSISTANCE FOR CALFRESH RECIPIENTS**

**WHEREAS**, the CalFresh program (known federally as the Supplemental Nutrition Assistance Program (SNAP)) is a federally funded program that provides critical food assistance to approximately 6,600 households and approximately 10,700 County residents; and

**WHEREAS**, as of November 1, CalFresh benefits may not issue which will have significant impacts to the health and safety of the children, adults and older adults in our community who rely on such food support; and

**WHEREAS**, the County has a budget policy specifically restricting backfilling of state or federal funds unless the Board determines it is a local priority and necessary to do so by a 4/5ths vote; and

**WHEREAS**, the disruption of funding for CalFresh benefits is unprecedented and will have serious consequences for the County’s most vulnerable residents who rely on the funds to feed themselves and their families; and

**WHEREAS**, providing funding for emergency food assistance under the current situation is critical to meet the Board of Supervisor’s local priority of strengthening equitable access to core services that protect health, safety, and wellbeing for all people as set forth in the Board’s 2025-2030 Strategic Initiatives; and

**WHEREAS**, the County and the Foundation have agreed upon the basic terms and conditions whereby the County will provide up to \$500,000 per month for the next two months for the Foundation to purchase and distribute emergency food assistance via gift cards from grocery retailers to CalFresh recipients working directly with County’s Health and Human Services Agency (HHS).

**NOW, THEREFORE, BE IT RESOLVED** the Napa County Board of Supervisors hereby finds that the use of Tobacco Master Settlement Agreement (MSA) Funds for the purpose of funding emergency food assistance provided to CalFresh recipients for this limited period is a local priority; and

**BE IT FURTHER RESOLVED**, that the Director of HHS is authorized to enter into a contract with the Foundation based on the following material terms and conditions, subject to review and approval as to form by County Counsel:

- a. County to provide up to \$500,000 per month for a maximum of \$1 million dollars to the Foundation, unless federal funding is restored or becomes available.
- b. The Foundation will distribute emergency food assistance to CalFresh recipients through a network of community-based providers working with HHSa for program verification.
- c. The Foundation shall provide support for administrative costs so that County funds are used only for the purchase of emergency food assistance that is given directly to CalFresh recipients.
- d. County shall notify the Foundation to immediately stop distribution and return unused funds and gift cards to the County in the event that: (i) funding for the CalFresh program resumes; or (ii) the County determines there are adequate other resources being distributed to CalFresh recipients.

# CalFresh Benefits Disruption

## Problem/Background – What's Happening

- CalFresh Benefit Disruption Anticipated in November (Saturday)
- Cut-Off; Benefits Are Not Expected to Issue as Normal (Normally, EBT Card Replenishment, November 1<sup>st</sup> – 10<sup>th</sup>)
- Benefits are 100% Federally Funded
- On October 20, the State Directed Counties to Prepare for Benefit Disruption & Inform Recipients of Available Resources
- Situation is Fluid; Tracking Closely



# CalFresh Benefits Disruption

  - Leverages NVCF “Match” of \$150K and Funding 100% of Administrative Costs
