**A RESOLUTION OF THE BOARD OF SUPERVISORS
CERTIFYING THE NAPA COUNTY PROBATION PROFESSIONALS ASSOCIATION
AS THE RECOGNIZED EMPLOYEE ORGANIZATION REPRESENTING THE NON-
SUPERVISORY PROBATION UNIT AND THE SUPERVISORY PROBATION UNIT**

WHEREAS, on December 3, 2019, the Napa County Probation Professionals Association (NCPPA), a registered employee organization, submitted two petitions for representation unit modification to establish a Non-Supervisory Probation Representation Unit and a Supervisory Probation Representation Unit; and

WHEREAS, on January 27, 2022, the Napa County Employee Relations Panel (Panel) unanimously voted to recommend establishment of a Non-Supervisory Probation Representation Unit and a Supervisory Probation Representation Unit; and

WHEREAS, on March 1, 2022, the Board of Supervisors established a Non-Supervisory Probation Representation Unit and a Supervisory Probation Representation Unit, and directed that a representation election be conducted for both units; and

WHEREAS, from April 5, 2022 to April 12, 2022, the Napa County Clerk conducted a representative election for the Non-Supervisory Probation Unit; and

WHEREAS, on April 14, 2022, the Napa County Clerk determined that the Non-Supervisory Probation Unit elected NCPPA as their Representative Organization; and

WHEREAS, from April 5, 2022 to April 12, 2022, the Napa County Clerk conducted a representation election for the Supervisory Probation Unit; and

WHEREAS, on April 14, 2022, the Napa County Clerk determined that the Supervisory Probation Unit elected NCPPA as their Representative Organization; and

WHEREAS, on April 23, 2022, the Panel accepted the results of the representation election for the Non-Supervisory Probation Unit and declared that NCPPA was elected as their Representative Organization; and

WHEREAS, on April 23, 2022, the Panel accepted the results of the representation election for the Supervisory Probation Unit and declared that NCPPA was elected as their representative organization; and

WHEREAS, based on the representation election results, the Panel recommends that the Board of Supervisors certify NCPPA as the recognized employee organization for both the Supervisory Probation Unit and the Non-Supervisory Probation Unit;

NOW, THEREFORE, BE IT RESOLVED that the Napa County Board of Supervisors hereby approves the following:

1. As of the date of this Resolution, the Board certifies the Napa County Probation Professionals Association as the recognized employee organization for the Non-Supervisory Probation Unit; and
2. As of the date of this Resolution, the Board certifies the Napa County Probation Professionals Association as the recognized employee organization for the Supervisory Probation Unit.
