Public Sector Revenue Loss



A Tradition of Stewardship
A Commitment to Service

- Recovered monies must be appropriated to eligible uses (e.g. public health response, public safety services, pay-go infrastructure)
- Base Year FY 2019 General Revenues \$165M
- Three-Year Average Growth Factor = 4.23%
- January – December 2020 Factored Revenues less Actual = \$3M *estimated revenue loss*
- Allocation Recommendation: \$0

Public Health Response



A Tradition of Stewardship
A Commitment to Service

- County spent \$20M+ through February 2021, received \$14M CARES Act grant
- County spent \$5M+ March 3 – June 30, 2021
- County will continue to provide eligible services in FY 2021-22, currently \$450,000 per month
- Allocation Consideration: \$9M over three years
