Procedural Redistricting Background

- Congress is divided into a Senate (2 per state) and a House of Representatives (435 members).
- Members of the House of Representatives are elected every two years and each represents a roughly equal number of US citizens.
- States are responsible for drawing lines within their borders to divide the population into 760,000 to 770,000-person congressional districts.
- The number of people living in an area goes up and down over time. The US Census, taken every ten years, counts the number of people living in the US.
- The results of the Census are used by the States every ten years to redraw congressional districts to reflect changes in population in an area and keep representation proportionate across districts.

California Redistricting Background

- Before 2010, the California Legislature drew congressional district maps, a practice still used by a majority of states.
- In 2010, California voters gave the job of redistricting to an independent commission known as the Citizens Redistricting Commission. By the 2022 election, the number of states using an independent commission grew to eight.

- States typically do not redistrict sooner than every ten years.
- However, this year, the State of Texas Legislature opted along party lines for a mid-cycle redistricting, the result of which is intended to be loss of 5 currently Democratic seats in the House.
- In response, Governor Newsom and the California Legislature voted, also along party lines, for a mid-cycle redistricting, the result of which is intended to be the loss of 5 currently Republican seats in the House.

Prop 50 Information

- Proposition 50 would temporarily return California to using congressional maps created by the California Legislature until after the 2030 Census.
- After the 2030 Census, the Citizens Redistricting Commission would regain authority to create maps using the results of the 2030 Census.
- Proposition 50 also calls for Congress to amend the U.S. Constitution and Federal law to require redistricting by “fair, independent, and nonpartisan redistricting commissions nationwide.”
- Passage of Proposition 50 would not change federal law or the U.S. Constitution, it would only show that voters support the idea of the use of independent redistricting commissions in other states.

A **YES** vote on this measure means: The state would use new, legislatively drawn congressional district maps starting in 2026. California's new maps would be used until the California Citizens Redistricting Commission draws new maps following the 2030 U.S. Census.

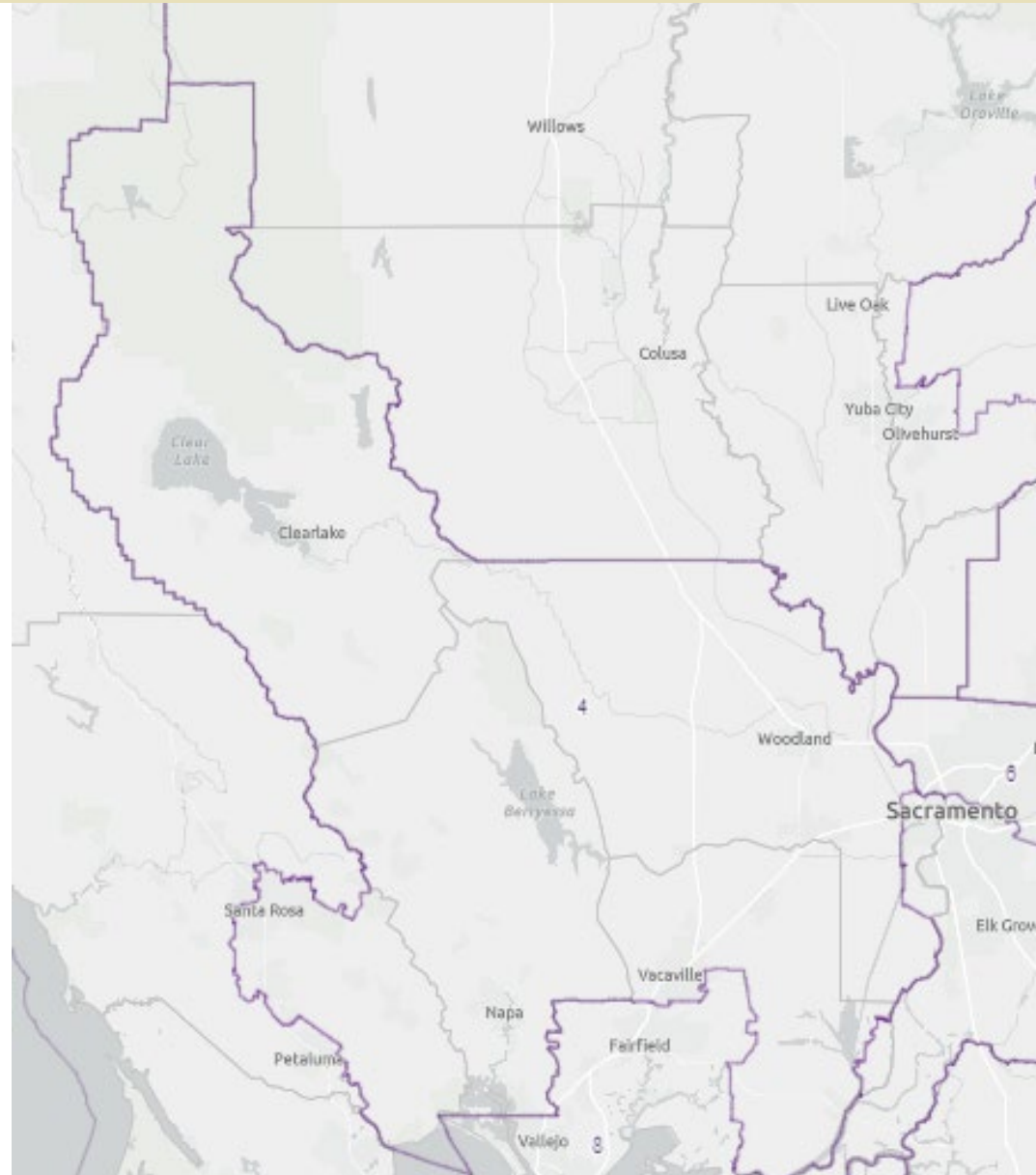
A **NO** vote on this measure means: Current congressional district maps drawn by the California Citizens Redistricting Commission (Commission) would continue to be used in California until the Commission draws new maps following the 2030 U.S. Census.

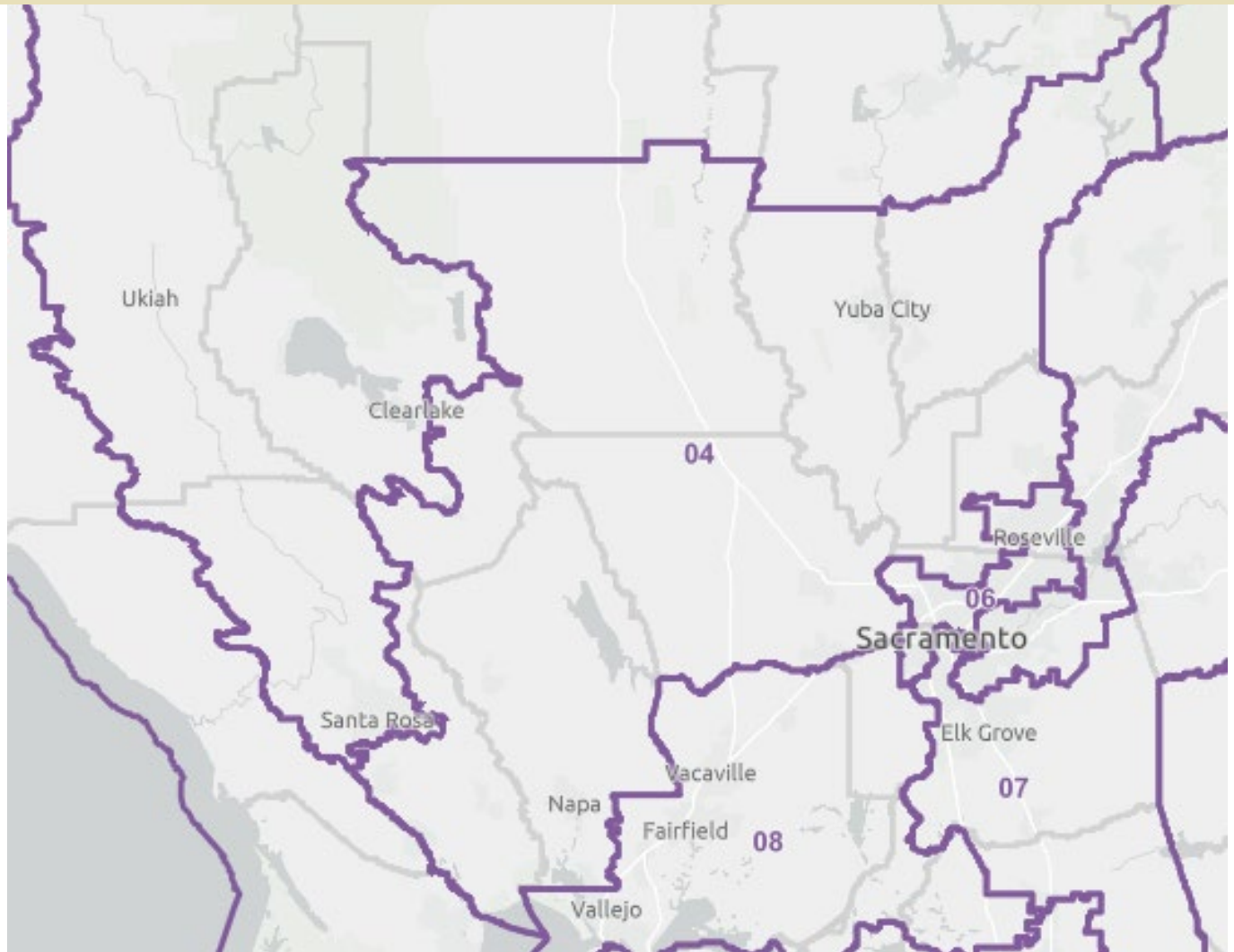
