RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE TABLE AND INDEX OF CLASSES AND DEPARTMENTAL ALLOCATION LIST FOR THE AUDITOR CONTROLLER, EFFECTIVE NOVEMBER 9, 2024.
