Overview of Peddling and Soliciting

Peddling is the act of selling goods or services directly to the public, typically by traveling from place to place or going door to door.



Regulations

- Napa County Code (NCC) Section 5. 40 Peddling and Soliciting

- · Government Code Chapter 6.2 Sidewalk Vendors
- · California Retail Food Code Section 113700-113733

Sidewalk Vending

- Sidewalk vending typically involves transient vendors selling items such as:
 - Fruit
 - Food
 - Flowers
 - Other merchandise
- These sales occur on sidewalks or within the public right-of-way



Public Health and Safety Concerns

- Food Safety and Handling
- Foodborne Illness
- Temperatures
- Sanitation
- Improper Storage
- Hygiene/Lack of access to handwashing, restrooms
- Pests

Public Safety and Environmental Concerns

- Traffic and Parking Issues
- Pedestrian Safety, Accessibility Issues
- Fire Hazards: Open Flame, Tents, Nearby Vegetation
- Litter/Waste Management
- Public Nuisance: Noise, Lighting
- Contaminated Disposal Storm Drains





Regulatory and Equity Concerns

- Avoidance of Permitting & Licensing Requirements
 - Business License
 - Health Department Permit
 - Food Handlers Permit
 - Insurance
- No Tax Collection/Reporting
- Unfair Competition for fully permitted business operators



Enforcement Obstacles:

Senate Bill 946

Sidewalk Vending. Codified in Government Code Chapter 6.2 Sections 51036 – 51039.



What SB 946 Accomplished:

Decriminalizes sidewalk vending

Limits local restrictions on sidewalk vendors

Prevents cities and counties from requiring sidewalk vendors to operate only in specific areas without cause

Restricts penalties for violations



What SB 946 Accomplished:

Mandates that local regulations be "reasonable"

Limits local restrictions on sidewalk vendors

Allows both stationary and roaming vendors

Requires local authorities to establish vending permit systems

• Change from criminal to administrative enforcement to align with State regulations



Summary



Staff recommends amending Napa County Code Section 5.40 to align with the Safe Sidewalk Vending Act (Senate Bill 946), which is set out in Chapter 6.2 of Division 1, Part 1 of Title 5 of the California Government Code (Sections 51036 – 51039) and clarify current code language. These changes will help ensure that the County's approach is consistent with state law, while also enhancing the effectiveness and fairness of enforcement efforts.
