RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE DEPARTMENTAL ALLOCATION LIST FOR THE HEALTH AND HUMAN SERVICES AGENCY, EFFECTIVE MARCH 2, 2024.
