

RESOLUTION NO. 2021

RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, CERTIFYING THE MILEAGE OF MAINTAINED COUNTY ROADS

WHEREAS, section 2121 of the California Streets and Highways Code provides that each county in the State of California shall submit to the California Department of Transportation any additions and/or exclusions from the county's mileage of county maintained roads as of May of each year, specifying the termini and mileage of each route added or excluded; and

WHEREAS, as authorized by the Napa County Board of Supervisors, the Napa County Department of Public Works certified to the California State Controller on May 19, 2020 that the total mileage of county maintained roads in Napa County as of May 2020 was 446.53 miles; and

WHEREAS, the Department of Transportation certified to the State Controller in the year that the total mileage of maintained County roads was 446.53 miles; and

WHEREAS, the Napa County Department of Public Works completed a thorough review of all county maintained roads for the 2020-21 Pavement Management Program Report and found that the total mileage of maintained county roads is now 419.10 miles; and

WHEREAS, the Napa County Board of Supervisors on March 2, 2021, accepted an additional 0.42 miles on Airport Road and Airport Road East into the maintained county road system earlier this year, which was the first addition or exclusion to the county maintained roads since 2020; and

WHEREAS, the Napa County Department of Public Works now finds that the total mileage of maintained county roads is now 419.10 miles;

NOW, THEREFORE, BE IT RESOLVED by the Napa County Board of Supervisors, as follows:

1. The total mileage of county maintained roads in Napa County is hereby authorized to be certified to the California Department of Transportation as being 419.10 miles as of April 2021.
2. The total mileage set forth in paragraph 1 above is the result of the additions and/or exclusions listed on page 1 of Exhibit "A", attached hereto and incorporated herein by this reference.

3. The total mileage set forth in paragraph 1 above are indicated in a GIS Shapefile that Public Works staff will submit to Caltrans, which is incorporated herein by this reference.
