RECITALS

WHEREAS, by Napa County Agreement No. 160078B-16 entered into as of April 19, 2016 (hereafter referred to as "Agreement"), CONTRACTOR agreed to provide preventative maintenance and inspection for the generators located in COUNTY owned or operated buildings; and

WHEREAS, on August 27, 2019, COUNTY and CONTRACTOR entered into Amendment No. 1 to the Agreement to increase the annual contract maximum by \$50,000, for a maximum of \$125,000, to cover a new generator located in the re-entry facility at 2200 Napa-Vallejo Highway, additional emergency and non-routine services, parts, repairs and equipment rentals throughout County properties; and

WHEREAS, the term of the Agreement and all extensions expires on June 30, 2021; and

WHEREAS, due to the COVID-19 pandemic restrictions within Napa County, it is not feasible to complete in-person site visits necessary to carry out a Request for Proposals process; and

WHEREAS, COUNTY wishes to extend the term due to the aforementioned difficulties; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement to extend the term for an additional two years through June 30, 2023, to increase the annual contract maximum by \$3,265 for a new maximum of \$128,265, increasing the scope of work to include regular service of two new towable generators located in the Corporate Yard at 7292 Silverado Trail and Roads Department at 4300 Spanish Flat Loop Road, and an increase in rates for routine, emergency and non-routine services-throughout County properties.

TERMS

NOW, THEREFORE, COUNTY and CONTRACTOR hereby amend the Agreement as follows:

- 1. Exhibit "A", "A-1", "B" and "B-1" of the Agreement is rescinded and replaced in full by that document entitled Exhibit "A-2" and "B-2", and all references in the Agreement to Exhibit "A", "A-1", "B" and "B-1" shall mean Exhibit "A-2" and "B-2", respectively.
- 2. Paragraph 1 is hereby amended to read in full as follows:
- 1. **Term of the Agreement.** The term of this Agreement shall commence on April 19, 2016, and shall expire on June 30, 2023, unless terminated earlier in accordance with Paragraphs 9 (Termination for Cause), 10 (Other Termination) or 23(a) (Covenant of No Undisclosed Conflict); except that the obligations of the parties under Paragraphs 7 (Insurance) and 8 (Indemnification) shall continue in full force and effect after said expiration date or early termination in relation to acts or omissions occurring prior to such dates during the term of the Agreement, and the obligations of CONTRACTOR to COUNTY shall also continue after said expiration date or early termination in relation to the obligations prescribed by Paragraphs 15 (Confidentiality), 20 (Taxes) and 21 (Access to Records/Retention).
- 3. Paragraph 2 is hereby amended to read in full as follows:
- 2. **Scope of Services.** CONTRACTOR shall provide COUNTY those services set forth in Exhibit "A-2", attached hereto.
- 4. Paragraph 3 is hereby amended to read in full as follows:
 - 3. Compensation.
- (a) <u>Rates.</u> In consideration of CONTRACTOR's fulfillment of the promised work, COUNTY shall pay CONTRACTOR at the rates set forth in Exhibit "B-2", attached hereto and incorporated by reference herein.
 - (b) Expenses. No travel or other expenses will be reimbursed by COUNTY.
- (c) <u>Maximum Amount.</u> Notwithstanding subparagraphs (a) and (b), the maximum payments under this Agreement shall be a total of ONE HUNDRED TWENTY-EIGHT THOUSAND TWO HUNDRED AND SIXTY-FIVE DOLLARS (\$128,265) for professional services per fiscal year; provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered.
- 5. This Amendment No. 2 shall be effective as of July 1, 2021.

6. Except as provided in 1, 2, 3, 4 and 5 above, the terms and provisions of the Agreement shall remain in full force and effect.

EXHIBIT "A-2"

SCOPE OF WORK

CONTRACTOR shall provide COUNTY with the following services:

I. DESCRIPTION OF SERVICES

CONTRACTOR shall provide COUNTY with **Semi-Annual** inspections and **Annual** service and load tests for the following generator equipment located at the sites designated. The services shall be performed on normal work days, defined as non-holiday Mondays through Fridays, 7:00 a.m. through 4:00 p.m. This will include testing of all controls for proper operation, system testing, written reporting, disposal of all fluids, and all prescribed maintenance in accordance with industry standards. The CONTRACTOR must comply with all local and State laws rules and regulations specifically including those related to generator maintenance.

Changes to Generator Equipment: It is understood by both CONTRACTOR and COUNTY that over the period of this Agreement, generator models and locations may change due to replacement or COUNTY facility requirements. Upon notification of the replacement or any new generators, CONTRACTOR shall provide COUNTY a cost schedule for maintenance that will be subject to approval by the COUNTY's Director of Public Works. Any increase in the cost of maintenance beyond the maximum compensation in this Agreement will require an amendment to the Agreement.

COUNTY has the right to remove from or add to the generators identified in this agreement, by providing CONTRACTOR thirty (30) days notice.

<u>Semi Annual Maintenance and Inspection:</u> Includes all items listed below and any other maintenance as required by the manufacturer, completed twice per year.

• Diesel fuel samples to be taken. Fuel to be tested for bacterial contamination and cetane level. If fuel is contaminated or if cetane level is lower than minimum specifications, contractor will make recommendations for treatment, filtering, or replacement.

Hours and Frequency of Service: All routine work will be performed between the hours of 7:00am and 4:00pm Monday through Friday, excluding COUNTY holidays. Should any generator equipment malfunction occur between routine examinations, CONTRACTOR shall provide call back service during regular working hours of regular working days at **no additional** charge.

If COUNTY authorized examinations, repairs or call back services are required, outside regular routine hours (7:00am and 4:00pm Monday through Friday, excluding COUNTY holidays) the CONTRACTOR will absorb the worked hours at regular hourly rates and will be reimbursed by the COUNTY for the difference between the regular hourly rate and the overtime or double time hourly rate as shown in Exhibit B.

Non Routine and Emergency Services: CONTRACTOR shall provide the COUNTY with authorized non-routine maintenance, authorized repair services and authorized emergency service for all generators as requested by the County's Director of Public Works or designee at the hourly rates and call out timing provided in Exhibit B, plus parts. CONTRACTOR must have ability to provide portable stand-by power if required/requested by the COUNTY.

<u>Minimum Certifications and Licensing:</u> A California C10-Electrical Contractor License is required.

II. COMPLIANCE WITH GOVERNMENT CODE SECTION 7550. As required by Government Code section 7550, each document or report prepared by CONTRACTOR for or under the direction of COUNTY pursuant to this Agreement shall contain the numbers and dollar amounts of the Agreement and all subcontracts under the Agreement relating to the preparation of the document or written report. The Agreement and subcontract dollar amounts shall be contained in a separate section of the document or written report. If multiple documents or written reports are the subject of the Agreement or subcontracts, the disclosure section may also contain a statement indicating that the total contract amount represents compensation for multiple documents or written reports.
