

## **RESOLUTION NO.**

### **RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, DESIGNATING FACILITIES AUTHORIZED TO PROVIDE EVALUATION AND TREATMENT OF PERSONS WITH MENTAL HEALTH DISORDERS PURSUANT TO THE LANTERMAN-PETRIS-SHORT ACT**

**WHEREAS**, California Welfare and Institutions Code (WIC) sections 5000, et seq., provides that the Board of Supervisors designate facilities authorized to provide evaluation and treatment pursuant to the Lanterman-Petris-Short (LPS) Act, and provides that such facilities may include, but are not limited to, a licensed psychiatric hospital, a licensed psychiatric health facility, and a certified crisis stabilization unit; and

**WHEREAS**, WIC sections 5150 and 5585.50 provide that a professional person in charge of a facility designated by a county for evaluation and treatment (designated facility), and attending staff of such designated facility, may, upon probable cause, take, or cause to be taken into custody persons for a period of up to 72 hours who, as a result of a mental health disorder, pose a danger to themselves or others, or are gravely disabled, and require assessment, evaluation, and crisis intervention, or placement in a designated facility; and

**WHEREAS**, on June 7, 2011, the Board of Supervisors passed Resolution number 2011-56 designating facilities authorized to provide evaluation and treatment pursuant to the LPS Act; and

**WHEREAS**, on April 18, 2017, the Board of Supervisors passed Resolution number 2017-62 in order to add the crisis stabilization unit to its list of designated facilities; and

**WHEREAS**, representatives of the facilities listed in Exhibit "A" have consented to being designated by the Board of Supervisors as facilities authorized to provide evaluation and treatment pursuant to the LPS Act; and

**WHEREAS**, the facilities listed in Exhibit "A" meet the necessary criteria to be designated as facilities licensed or certified to provide evaluation and treatment pursuant to the LPS Act, and Exhibit "A" now removes reference to the specific contractor operating the crisis stabilization unit.

**NOW THEREFORE BE IT RESOLVED** that the Napa County Board of Supervisors designates the facilities listed in Exhibit "A" to provide evaluation and treatment pursuant to the LPS Act.

**BE IT FURTHER RESOLVED** that the Mental Health Director is authorized to designate 5150 site coordinators at the facilities listed in Exhibit "A" who shall ensure that professional persons in charge of the facilities, and their attending staff, attend initial and ongoing training, and shall be certified to initiate involuntary detentions pursuant to WIC sections 5150 and 5585.50.

**BE IT FURTHER RESOLVED** that effective with the adoption of this Resolution, the Board of Supervisors hereby rescinds all prior Resolutions regarding designated facilities to the extent they are in conflict with this Resolution.

**BE IT FURTHER RESOLVED** that this Resolution shall take effect immediately upon its adoption by the Board of Supervisors.
