**PROFESSIONAL SERVICES AGREEMENT- AMENDMENT NO. 1**

**THIS AMENDMENT NO. 1 TO AGREEMENT 210073B** is made and entered into as of this     day of     , 2021 by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Tritek Systems Inc., a Delaware corporation, whose business address is 1 Medori Blvd, Wilmington DE 19801-5777, hereinafter referred to as "CONTRACTOR."

**RECITALS**

**WHEREAS**, COUNTY wishes to amend Agreement No. 210073B to obtain an upgrade to the ballot sorting software provided by Tritek, relating to ballot sorting and signature verification, and associated licenses and training; and

**WHEREAS**, CONTRACTOR is willing to provide such software upgrade to COUNTY under the terms and conditions set forth herein.

**TERMS**

**NOW, THEREFORE**, COUNTY hereby engages the services of CONTRACTOR, and CONTRACTOR agrees to serve COUNTY in accordance with the terms and conditions set forth herein:

1.     **Scope of Services.** CONTRACTOR shall provide COUNTY those services set forth in Exhibit "A to Amendment No. 1," attached hereto and incorporated here by reference.

2.     **Compensation.**

      (a)     **Rates.** In consideration of CONTRACTOR's fulfillment of the promised work, COUNTY shall pay CONTRACTOR as set forth in Exhibit "B to Amendment No 1," attached hereto and incorporated here by reference.

3.     All other terms of Agreement No. 210073B not modified by this Amendment No. 1 shall remain in full force and effect.
