## RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING COUNTY POLICY MANUAL PART I: SECTION 37BB, HIRING AND PROMOTIONAL INCENTIVE PILOT PROGRAM, EFFECTIVE OCTOBER 1, 2021

**WHEREAS,** Government Code Section 25300 provides that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of county employees and that such action may be taken by ordinance or resolution; and

**WHEREAS,** it is difficult for the County to recruit and hire qualified individuals into certain job classifications; and

**WHEREAS,** since 2017, the County has been offering various hiring and promotional incentives through a pilot program to increase the likelihood of hiring qualified individuals into such job classifications; and

**WHEREAS**, the Hiring and Promotional Incentive Pilot Program is set to expire at the end of 2021; and

**WHEREAS,** the Human Resources Director has reviewed County Policy Manual Part I: Section 37BB, Hiring and Promotional Incentive Pilot Program and believes it continues to increase the likelihood of the County hiring qualified individuals into certain job classifications which are hard to fill; and

**WHEREAS,** as a result of this review, the Human Resources Director recommends that County Policy Manual Part I: Section 37BB be amended to make various changes to the language and the program, including extending the term and revising the timing of signing bonuses and vacation leave banks; and

**WHEREAS**, therefore the Human Resources Director recommends that County Policy Manual Part I: Section 37BB be amended, as set forth in Exhibit "A."

**NOW, THEREFORE, BE IT RESOLVED,** that the Napa County Board of Supervisors hereby amends County Policy Manual Part I: Section 37BB, Hiring and Promotional Incentive Pilot Program, as set forth in Exhibit "A," effective October 1, 2021.
