NAPA COUNTY AGREEMENT NO. 170151B AMENDMENT NO. 3

PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT NO. 3 TO NAPA COUNTY AGREEMENT NO. 170151B is made and entered into as of this first_day of July, 2021, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and GOVERNMENTJOBS.COM, INC., a California Corporation (dba NEOGOV), whose mailing address is 300 Continental Blvd., Suite 565, El Segundo, CA 90245, hereinafter referred to as "CONTRACTOR";

RECITALS

WHEREAS, COUNTY and CONTRACTOR entered into Napa County Agreement No. 170151B (previously 6645) on June 6, 2006 ("Agreement") to provide Insight Enterprise Edition, a web-based recruitment, selection and applicant tracking software solution; and

WHEREAS, COUNTY and CONTRACTOR amended the Provision of On-line Services, Term and Termination and Payments effective July, 1, 2018; and

WHEREAS, COUNTY and CONTRACTOR amended the Provision of On-line Services, Term and Termination and Payments effective May 21, 2019; and

WHEREAS, COUNTY and CONTRACTOR again desire to amend the Provision of Online Services, Term and Termination and Payments;

TERMS

NOW, THEREFORE, COUNTY and CONTRACTOR agree to amend the Agreement in accordance with the terms and conditions set forth herein:

1. Paragraph 1. Provision of On-line Services. Section (a) is amended to read in full as follows:

1. Provision of On-line Services.

(a) Customer herby engages NEOGOV, and NEOGOV hereby agrees (subject to the terms and conditions set forth herein) to provide the services (the "Services") more fully described in the Agreement and in the system overview attached hereto and incorporated by reference herein as Exhibit A (the "System Overview") and in the Order Form collectively attached hereto and incorporated by reference herein as Exhibit B and Exhibit B-3. Customer hereby acknowledges and agrees that NEOGOV's provision and performance of the Services is dependent and conditioned upon Customer's full performance of its duties, obligations and responsibilities hereunder.

- 2. Paragraph 9. Term and Termination. Section (a) is amended to read in full as follows:
 - 9. Term and Termination.
 - (a) This Agreement shall commence as of June 6, 2006, and remain in effect through June 30, 2022 and thereafter the term shall be automatically renewed for an additional year at the end of each fiscal year, under the terms and conditions then in effect, not to exceed two (2) additional years, unless either party gives the other party written notice of intention not to renew no less than sixty (60) days prior to expiration of the then current term. For purposes of this Agreement, "fiscal year" shall mean the period commencing on July 1 and ending on June 30.
- 3. Paragraph 10. Payments. Section (a) is amended to read in full as follows:
 - 10. Payments.
 - (a) *Initial Term*. See Exhibit B and Exhibit B-3 (Order Form). All references to Exhibit B-3 shall be effective as of the effective date of Amendment No. 3.
- 4. Exhibit "B-3", attached hereto and incorporated herein by this reference, is hereby attached to and incorporated into the Agreement.
- 5. Except as provided above, the terms and conditions of the Agreement shall remain in full force and effect as originally approved.
