**RESOLUTION OF THE BOARD OF SUPERVISORS OF NAPA COUNTY,  
STATE OF CALIFORNIA, APPROVING AND AUTHORIZING THE  
CHAIR TO EXECUTE THE MAINTENANCE AGREEMENT WITH  
CALTRANS FOR THE NAPA VALLEY VINE TRAIL BETWEEN ST.  
HELENA AND CALISTOGA**

**WHEREAS**, on October 20, 2020, the Napa Valley Transportation Authority (NVTa) and the California Department of Transportation (Caltrans) executed Cooperative Agreement 04-2749 to design and construct the Napa Valley Vine Trail (NVVT) between St. Helena and Calistoga; and

**WHEREAS**, Napa County will be responsible for maintaining the NVVT between St. Helena and Calistoga after it is constructed; and

**WHEREAS**, NVTa will construct portions of the NVVT in the Caltrans right-of-way and Caltrans requires a written agreement for Napa County to maintain facilities in their right-of-way; and

**WHEREAS**, the Cooperative Agreement anticipates that Caltrans and Napa County will execute a project specific maintenance agreement prior to construction completion;

**NOW, THEREFORE, BE IT RESOLVED** by the Napa County Board of Supervisors as follows:

1. The Project Specific Maintenance Agreement between CalTrans and Napa County for the portion of the NVVT between St. Helena and Calistoga is hereby approved.
2. The Chair is authorized to execute the Project Specific Maintenance Agreement for and on behalf of Napa County.
